ITEMS OF LOCAL INTEREST.

Mrs. Weaver, wife of Calvin Weaver Sr., in Ebersburg, who had been seriously ill, is improving.

Mrs. C. A. Krape of Spring Mills, was a pleasant caller at the Reporter office last Friday.

Nathaniel Boob, a Civil War veteran in his eighty-seventh year, a resident of Millheim, is seriously ill from complications due largely to his advanced age.

County Agent R. C. Blaney recommends that cows, when turned to pasture this spring, be fed the same grain ration as before. Later, the grain may be reduced.

Mr. and Mrs. Louis E. Allis, on last Thursday drove to Capton for a day's meeting in which they were interested and back in time for an evening gathering in Centre Hall.

Harry Snavey, tenant on the Allison farm at Spring Mills, continues to improve after a rather prolonged and serious illness. While not yet able to do farm work he is doing "linking" about the premises.

The postmasters in Pennsylvania will hold their annual convention in Williamsport, June 27 and 28. The time actually used in traveling to and from the convention with that spent in attendance will be allowed with pay.

While burning rubbish in a lot in the southern section of town, the middle of last week, the fire broke from its center and spread to a heavy covering of dead grass. It was necessary to call help before the flames could be subdued.

Tuesday was scheduled as the time for opening the proposals or a site for the proposed post office in Bellefonte, but it will be some time before the question of a location is settled. The location is always the big problem when the National Government appropriates money for public buildings.

Up to the middle of this month more than 500 forest fires already have been reported this spring. Deputy Secretary John W. Keller reports that the forest floor is highly inflammable and fires spread rapidly. It is essential that brush burning be delayed until it rains and that the utmost care be exercised in all other activities which are liable to cause forest fires.

Two of the best wheatfields in all Brush Valley will be found on the John Wolf farm, now owned and operated by Frank P. Stover. Mr. Stover is counted a high-class farmer and is said to raise better crops on his farm than was done by previous owners or tenants. The Wolf farm for many years was counted a heavy producer.

Mechant Nieman, in Millheim, is improving the interior furnishings of his store room. A counter in use for more than sixty years, although in good condition, is being discarded. The counter escaped destruction when the Snook store building burned, it having been removed to a stable several months prior to the fire, but when the present building was furnished it was brought out and put to use again.

Mr. and Mrs. H. G. Strohmeyer and Mr. and Mrs. Clayton Homan, on Sunday, visited Mr. and Mrs. Irvin Shirik, at Glen Iron, and report Mr. Shirik improving from a paralytic stroke that affected his left side. He had been away from home, and on returning put the car in the garage and shortly after reaching the house the affliction came on, and this was only a few hours after she had mailed the letter to the Reporter appearing in this issue.

J. Wesley Foreman has been removed from the Centre County hospital to his home in the Farmers Mills district, and is reported to be very much improved. It will be recalled that owing to complications arising after a paralytic stroke it became necessary to remove one of his lower limbs above the knee. The leg had healed nicely. Mr. Foreman had also lost his speech, and this has come back again. He is very hopeful of recovering more fully.

Funeral services will be held this (Thursday) morning from the home, with services by Rev. D. R. Keener, and burial in Georges Valley cemetery.

She was a daughter of M. and Mrs. Jefferson Houtz, of Lemont, and was born at Spring Mills. She is survived by her husband and one son, Malcolm, of Tyrone. She is also survived by her parents and one sister, Mrs. Roy Corl, of State College.

Funeral services were held at her home Sunday afternoon, in charge of the Rev. William C. Thompson, pastor of the Presbyterian church; interment in the Union cemetery, Bellefonte.

CONDO.—Mrs. Nora Condo, aged 77 years, widow of Howard Condo, of Mill Hall, died at the Lock Haven hospital Saturday morning following several years' illness of a complication of diseases.

Mrs. Condo was born in Brush valley and had resided all her life there and in Sugar Valley. She had for many years been a member of the Evangelical church at Loganton.

P. S. C. SCIENTISTS

NOMINATED FOR AWARD

Three agricultural scientists on the staff of the Pennsylvania State College have been nominated for the 1931 "Capper Award for Distinguished Service to American Agriculture." Dr. Ernest L. Nixon, Dr. Charles F. Noll and Dr. Ernest Forbes. The award is the highest existing honor that can be bestowed for work in agriculture in this country.

Dr. Nixon, the "Pennsylvania Potato Wizard," was nominated for his nation-wide success in improving yield and quality of the potato crop. Following introduction of his methods the average potato yield in Pennsylvania has been increased from 80 to 130 bushels to the acre, while the record crop has been recorded at 696.1 bushels to the measured acre.

Dr. Noll is best known for his development of "Pennsylvania 44," wheat that is mentioned wherever prime yielding cereal crops are discussed, and Dr. Forbes is noted for the work he has done and is performing as director of the Institute of Animal Nutrition at the college.
