A project under contemplation with CWA labor in Gregg township sponsored by the Forestry Department of the State, if carried out will give employment to a large number of men for a considerable length of time. The road will lead by the Synagogue church and crosses the road through Decker Valley at the Gentzel place.

Community Hall a CWA Project—One of two projects sponsored by the Gregg Township school board is the erection of a handsome and modern community hall, and the other the improvement of the Vocational School athletic field. The papers for the first project named are now in Washington and there is almost a unanimous sentiment favoring its adoption by the twp. taxpayers. The second project is now being carried out, considerable work having already been done. The plan provides for an expenditure of \$1200 to \$1500, for draining and grading. Five hundred feet of the have been laid and part of a bank on the north side of the field cut away. When

completed the field will be all that can be desired by any High school athlete group.

The community hall project calls for a substantial brick structure of the dimensions of 55x75 feet, one-story in height, with a hip-effect roof. The estimated cost is placed at from \$6000 to \$8000, and the money outlay to Gregg township at about \$4000. This sum will be borrowed from the Public Works Administration, and the payment extended over a long period of years. The board has already taken measures for the annual payment required by increasing the per capita tax by one dollar.

The school board met with Wm. L. Steele, contract builder and architect, to formulate the tentative plans for the building. The auditorium will be on the ground level, with a foyer, stage and kitchen. There will be no basement, except to accommodate heating equipment. The school board, of which H. S. Lambert is the secretary, is a unit in its support of the movement.
