RELIEF FUNDS FOR CENTRE

\$27,212.52 TO MAY FIRST

Centre county has been apportioned \$27,212.52 for the jobless up to May 1st. This is from a total of \$9,739,355 allocated by the State board, the balance remaining being but \$421,550. A further Federal grant will be necessary after May 1st.

Although the 1933 special session of the State Legislature appropriated \$20,000,000 for relief purposes from anticipated liquor store profits, this amount has not yet been produced.

SENATOR REED TO VOTE AGAINST THE BONUS BILL

And now Senator David A. Reed comes out with a statement that he will vote against the bonus when it comes up again in the Senate. Addressing a gathering of veterans in Philadelphia, Thursday night, Senator Reed said that military service in an emergency is a patriotic duty requiring neither compensation nor reward. Another expression was, "the government owes no money whatever to veterans like myself who came out of the war as well as they went in."
