**DEMOCRATS GAIN 2500 WHILE  
REPUBLICANS LOSE 1900 IN  
CENTRE CO. REGISTRATION**

While the complete registration of  
Centre county is not yet obtainable,  
all the districts except four are  
available. These registrations as now  
recorded give the Democrats a gain  
of 2500 over that of a year ago, and  
Republicans' loss approximately 1900.

The complete registration for all  
but four precincts in the county is  
as follows: Democrats, 19,913; Repub-  
licans, 13,541. This represents an in-  
crease of 2500 for the New Dealers  
and a loss of 1918 for the Republicans.

40 pupils are expected. This will be  
the largest class in the past 10 years.  
In Miss Orrie Wagner's first and sec-  
ond grades there will be 46 children,  
which is the same enrollment.

In the third and fourth grades of  
which Louella Rosark is teacher, 40  
pupils, and in the fifth and sixth  
grades, taught by Harry K. Condo, 32  
pupils will be enrolled.

At present besides the Spring Mills  
school, there are six one-room rural  
schools in operation. Ultimately these  
will be consolidated.


