H. O. P. SENATORS SHOW "THEY CAN'T TAKE IT"

State Senate Republicans, fearful that the folks back home might read a vigorous denunciation of their do-nothing record on relief, demonstrated prior to their unprecedented action in adjourning without providing relief funds for June, that they cannot stand criticism.

They expunged a speech by Senator Calvacante of Fayette county, from the record, so that the people of the State could not read it.

Senator E. J. Thompson of Centre county had offered a resolution for immediate appropriation of \$55,711,446 for direct relief to January 1. He said the Senate should stop its dillydallying and pointed out that all the Republican Senators had done was to vote their own salaries. The Republicans killed the resolution.

Senator G. Mason Owlett, of Tioga, then launched a partisan political attack upon Senators Thompson and Calvacante. Senator Calvacante replied, placing much of the blame for the threatened destitution of the needy upon Senator Owlett. He called upon Senator Owlett to serve the corporation for which he is attorney less, and the people more.

Senator Calvacante's attack was so destructive in the opinion of the Republicans, that Senator Buckman, of Bucks, scurried around his Republican colleagues, and then moved that the entire debate be expunged from the record. The Republicans then voted to expunge.

"All I have to say," Senator Thompson declared to the Republicans, "is that you can't take it."

THOMPSON TO OPPOSE PINOLA FOR STATE TREASURER

"Constitutional Justice" is the title pre-empted by a group of independent Republicans in Pennsylvania. Their chief object is to defeat Pinola, the Republican candidate for State treasurer, and elect Frank B. Thompson, who was second to Pinola as a vote getter at the primary when the State ticket was elected.

George F. McCann, who in 1934 was vice-chairman of the Independent Republican committee in Philadelphia, is heading the independent movement. It is claimed Pinola is a weak candidate. Another objection is the source of his campaign funds, which came from Grundy, \$20,000; A. W. Mellon, \$5,000; W. L. Mellon, \$5,000; Joseph N. Pew, Jr., G. O. P. boss and Liberty Leaguer, \$15,000; J. Howard Pew, \$5,000. These contributions are quoted as having been especially opposed to Mr. Thompson and favorable to Pinola.

BYRNS, SPEAKER OF THE HOUSE, DIED THURSDAY

A state funeral in the National House chamber on Friday for Speaker Joseph Wellington Byrns, cut down at the height of his career by a sudden heart attack and cerebral hemorrhage, was held by grief-stricken congressional leaders.

The President accompanied the funeral train to Tennessee.

The Speaker had attained his 66th year. He will be succeeded as Speaker by William B. Bankhead, of Alabama.

Funeral services were held on Tuesday forenoon, Rev. L. A. Wagner, pastor of the Lutheran church, of which denomination the deceased was a member, officiating. Burial was made in the local cemetery.

WAGNER.—Mrs. E. Clayton Wagner died at the Centre County hospital on Friday evening, following a protracted illness of a few days. Funeral services were held from the home at Pottery Mills, Monday afternoon, and burial made in the Zion Hill cemetery, near Tusseyville, Rev. W. K. Hosterman of the Evangelical church and pastor of the deceased, officiating.

The maiden name of the deceased was Maude Gunsallus, a daughter of Clarence and Katharine (Sweeney) Gunsallus. She was aged 57 years, 2 months and 22 days.

She is survived by her husband and three children, namely, Ernest and Chester, at home, and Mrs. William Hanna, Centre Hall.

SPANGLER.—William E. Spangler passed away at the Norwegian-American Hospital, Chicago, Ill., Tuesday of last week, at the age of 62 years, 8 months and 8 days, after several months' illness.

Mr. Spangler was the son of William and Adella Spangler and was born on their farm near Pottery Mills. He spent his early days assisting his father on the farm and taught school several terms in Potter township before going to Chicago in 1895, where he engaged in business. Mr. Spangler was twice married, his first wife being Irene Palmer, of Pottery Mills, who preceded him in death 25 years ago. To this union there were born three children, Mrs. Miriam Gooley Park Ridge, Ill.; Arthur, of Terre Haute, Indiana, and Carl. There survive him his widow, Irene Nevis Spangler, Mrs. Gooley, and Arthur, Carl having died in infancy; also five grandchildren, two great-grandchildren; Gertrude, a sister, residing in Oakland, Calif., and Harry, a brother, of Park Ridge, Ill. Another brother, Bernard, died in 1920.

Funeral services were conducted by Rev. Elmer L. Williams, pastor of the Ravenswood Methodist church, Chicago, Thursday afternoon, June 4. Interment in Rosehill cemetery.

CONFER.—Perry Franklin Confer well known retired farmer, died at his home in Rebersburg, at the age of 80 years. He suffered a paralytic stroke last August, from which he never fully recovered.

The deceased was born in Gregg township, March 8, 1855, the son of Peter and Hannah (Zerby) Confer, and grew to manhood as a tiller of the soil. He was married in 1879 to Mary M. Houtz, who survives him.

In addition to his widow, Mr. Confer is survived by five children: Mrs. T. A. Braucht, Woodward; John A. Confer, of Chicago, Ill.; Harry A. Confer, of Madisonburg, and Mrs. Florence Laltue, and James A. Confer, of Rebersburg. Eighteen grandchildren also survive, as do three brothers: John Confer, of Millheim; Emanuel C., of Madisonburg; and Edward Confer, of Chicago, Ill.

Funeral services were held Thursday of last week and burial made in Millheim.

CENTRE COUNTY FARMERS USE NEW DEAL CREDIT

Farmers in Centre county have received loans from two divisions of the Farm Credit Administration totaling \$114,100 from May 1, 1932, to January 1, 1936, according to an announcement made by N. L. Lichtenwalner, State Director of the National Emergency Council.

The Federal Land Bank made 25 loans in the county, totaling \$58,500, mostly long-term, low-interest rate loans secured by first mortgages on farms.

Thirty-one loans were made by the Land Bank Commissioner, totaling \$55,600 for refinancing existing indebtedness and to finance emergency needs of farmers.

A total of 8681 loans, amounting to \$16,959,500 were made for the State of Pennsylvania. 3510 loans, totaling \$8,360,200 were made by the Federal Land Bank, and 5171 loans were closed by the Land Bank Commissioner for a total of \$8,529,400.

751 GRADUATE AT PENN STATE; 75 FROM COUNTY

The Pennsylvania State College awarded degrees to 815 students on Monday at the 76th annual commencement. President Ralph D. Hetzel conferred the degrees on 751 members of the senior class and 67 graduate students.

The seniors presented the college with a \$4000 class memorial, directing that \$2000 be spent to rebuild the pipe organ in Schwab Auditorium, and \$1000 be used to purchase astronomical photographic equipment.

Miss Janet Beman, State College, delivered the salutatory address and S. James Zarger, Chambersburg, gave the valedictory.

Of the seventy-five from Centre county to graduate, fifty-three are from State College. Graduates from other points in the county include:
