FARM CALENDAR. Timely Reminders from Pennsylvania State College School of Agriculture

Furnish Farm Power—Horses and mules furnish reliable power, ready at all times. This power is flexible, because it can be used in units of any size—one horse in the garden, two on the wagon, two or more on the manure spreader, 4 to 6 on a plow, and more on heavier tools, say horse specialists of the Pennsylvania State College.

Save Damaged Trees—Prompt inspection of the orchard should be made to determine whether any of the fruit trees have been damaged by mice. Injured trees will need bridge-grafting with out delay, declare Penn State fruit specialists. If this operation is postponed until growth starts the loss will be greater.

Prepare Lamb Crop—To prevent reduced returns on the lamb crop, all lambs should be docked and all male lambs intended for market should be castrated. These two operations may be performed at the same time, but Penn State sheep specialists recommend docking when the lambs are 5 to 10 days old and castrating when the males are 2 to 3 weeks old.

Add Organic Matter—Manure of green manure crops, especially a clover sod, turned down in the rotation, will build up the organic matter and increase the water-holding capacity of the soil, say State College vegetable gardeners.

Prevent Soil Washing—Many farmers are using the sensible practice of plowing washy slopes in strips, 100 feet or more wide, and leaving alternate strips of equal width in sod, report Penn State agronomists. These sod strips can be plowed next spring when the other strips are in grain preferably winter grain.

Feed Ewes Liberally—Breeding ewes should be fed liberally in order to produce a good healthy lamb crop according to Penn State sheep specialists. A good legume hay, such as clover or alfalfa, fed with a grain mixture composed of 5 parts of oats, 2 parts of corn, 1 part of bran, and 1 part of pea-sized oil cake, will insure a good milk flow.

Mr. Dippery was a resident of State College, a son of Rush K. and Eva Bubb Dippery, his parents being formerly of Potter township. In the prime of life, the deceased passed away at the age of 28 years, 4 months and 2 days. He leaves a wife, formerly Miss Phyllis Hoy, of State College, and a son, Gibson. Also, both his parents and a brother, Walter, all of State College.

The deceased was an employee of the Centre Daily Times. In connection with a notice of the death the Times makes this reference to him as a workman: Mr. Dippery started work with the Centre Daily Times at its inception as a daily three years ago and was one of the most loyal and efficient workmen in its employ.
