**PERMANENT CO. REGISTRARS**  
SELECTED BY COMMISSIONERS

Under the new registration law applying to the entire state, other than cities having previously had a similar law in force, there will be three registration days in each voting district on which days voters must appear personally to be registered to become eligible to vote at all future elections. The registration days are June 18, July 16, and August 6th.

A registrar representing the two major parties will perform the service. They will act only on the three days named and will have nothing to do with the regular election.

The appointments of registrars is equally divided between the Democratic and Republican parties and is made from persons recommended by the county chairman in each party.

In most if not all cases the elected registration assessor will represent his party as the registrar from the district he serves.

On each registration board will be a secretary, preferably a typist.

**Deaths**

**DUCK.**—Stricken with a heart attack, Rev. Elkanah M. Duck, of Jersey City, N. J., formerly of Spring Mills, died in his apartment at that place last week. He had been in his usual good health and his death was a great shock to his family and friends. The deceased was born on a farm in Penns Valley, near Spring Mills, Aug. 21, 1872, the fourth of a family of four boys and four girls. His parents were Michael B. and Sarah Tressler Duck, both deceased.

His early education was received in the public schools of Centre county, and he later taught several terms in the county. He prepared for a college education in the Spring Mills Academy. In 1897 he graduated with honors from Gettysburg College, and also won the Latin prize—a gold medal—which he highly prized. Completing his college course he taught for a few years in a seminary, privately owned by Dr. Henry Upson, in New Preston, Conn. At the same time he was preparing to enter the Union Theological Seminary in New York City to prepare for the ministry. His three years' course in the Seminary was taken entirely on scholarships. He also won the scholarship given at that time by the Seminary, which gave him a two years' course at Heidelberg University, Berlin, Germany.

On his return from Germany, Dr. Upson still maintaining a deep interest in him, kindly urged him to join the Reformed church and accept a pastorate at Rosendale, N. Y. His rich and fruitful ministerial work was continued at Montville, N. J., and Jersey City. He resigned as pastor of the Greenville Reformed church in Jersey City a few years ago that he might do supply work and have more time to devote to other lines of work. At the time of his death he was about to publish a book on "The Philosophy of Religion."

Rev. Duck's demise was not discovered immediately as he was often absent from his rooms, on duties and visiting a sister, Mrs. Phillips, in New York City. Having never married his first interests and care were for the brothers and sisters who have sustained a great loss in his passing. They are as follows: Mrs. Lila Hettinger, A. L. Duck, and Magnus T. Duck, all of

Spring Mills; Mrs. Blanche E. Phillips, of New York City; Bertha, wife of W. E. Burkholder, Phillipsburg, and Charles C. Duck, of Lewistown. One sister, Florida, died in 1920.

Funeral services were held in the Jersey City church which he served as pastor for twenty years, on Friday evening, June 11th, after which the body was brought to Spring Mills and Saturday forenoon with graveside services was laid to rest in the family plot in Heckman cemetery, near his boyhood home.

The thoughts of the poet can truly be said of him; he lived for those who loved him; for those who knew him true; for the heaven that smiled above him, and awaited his spirit too.

**LIMBERT.**—Minnie Dora Erdley, wife of Herman S. Limbert, died at her home in Gregg township, on Route No. 95, leading east from Centre Hall, on Monday. She was the daughter of George F. and Rebecca Mease Erdley, both deceased, and was born Nov. 1, 1876, at Lewisburg. Her age at death was 60 years, 7 months and 13 days.

Mrs. Limbert was the second of a family of nine children to depart from this earth. There survive her husband, previously named, and these brothers and sisters: Charles E. Erdley and John M. Erdley, Lewisburg; Wm. J. Erdley, Mifflinburg; Mrs. Lizzie Miller, Mrs. Elmedia Grove, Mrs. Ida Herman and Mrs. Lottie I. Schwarm, all of Lewisburg. A brother, Thomas Erdley, died in 1928.

The marriage of Mr. and Mrs. Limbert took place March 5, 1912. They began their married life on the farm of her father in Union county, and in 1914 the couple located at their present home to engage in the same occupation.

Mrs. Limbert was a devoted wife and loved her home and nature. Burial will be made today (Thursday) at Madisonburg from the Reformed church, Rev. Paul Miller, the pastor, officiating, following services at the home at 2:00 p. m.

**WHITEHILL.**—Mrs. Bertha Marlor Whitehill died at her home, near Oak Hall Saturday morning at 5 a. m. She had been ill for one week. Death was attributed to quinsy.

Mrs. Whitehill was 35 years old at the time of her death, and was the daughter of Thomas and Rebecca Runkle Weaver, both of whom are deceased. She was born in Spring town-

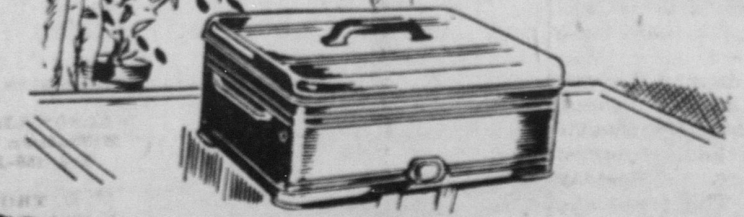
