SCHOOL DIST'S REIMBURSED FOR HIGH SCHOOL TUITION PAID Auditor General Warren R. Roberts has approved payments aggregating \$298,589.99 to school districts in 55 counties of the State to reimburse those districts for high school tuition. The payments are to be made under the provisions of Section 1711-A of the School Code, which requires the State to reimburse school districts for high school tuition when they are required to pay tuition for pupils attending high school in another district.

Centre county comes in for an appropriation of \$72,711.82 for high school tuition.

107 Days in Centre County Jail for Killing Bear. Walt Davey, of Blanchard, is spending 107 days in the Centre county jail as the result of killing a bear out of season. Davey was arrested by Game Protector Thomas Mosier and at a hearing before Squire George Eaton of Blanchard pleaded guilty to the charge. Unable to pay the fine and costs totalling \$107, Davey was committed to jail.

Deaths

ALLISON.—Harry M. Allison, former Spring Mills postmaster and more recently conducting a self-owned Clover Farm store in that village, died at 12:30 o'clock Monday morning at his home as the result of a paralytic stroke suffered Wednesday of last week. Mr. Allison was postmaster under the Republican Administration of Presidents Harding and Coolidge, and served for a period of nine years. At one time he operated a grist mill in Spring Mills. The deceased was born in Clintondale, December 17, 1869. He was a son of Archibald and Jane Gettig Allison. His first wife, the former Clary A. Steele, died in January of 1920. In August of the following year he married Lulu Boob, who survives. Two sons to the first union, Eugene, of Reno, and Clair, of Jamestown, N. Y., survive. Prof. A. Merril Allison of Chicago, is a surviving brother. The deceased was a member of the T. O. O. F. lodge of Spring Mills. Funeral services were held at the home Wednesday afternoon at 2:00 o'clock with Rev. Delas R. Keener of Centre Hall and Rev. I. R. Miller of Spring Mills officiating. Interment was made in the Spring Mills cemetery. KING.—George Calmer King, longtime resident of Gregg township, died at his home in Spring Mills Monday afternoon at 4:00 o'clock, from a heart attack. He had been ill for several years, during which time he suffered several strokes. Mr. King was the son of George I. and Mary Garbrick King, and was born at Oak Hall, April 30, 1866, hence was 73 years, 7 months and 3 days of age. He was employed as a laborer and late in life did some auctioneering in Gregg township. His widow, Anna A. (Krape) King survives. There were no children to their union. No brothers or sisters survive. Funeral services will be held this (Thursday) afternoon at 2:00 o'clock at the home and continued in the Reformed church at Spring Mills. Rev. D. R. Keener will officiate. Burial will take place in the Farmers Mills cemetery. DAVIS.—Funeral services were held Friday afternoon at the Neff funeral home in Millheim for Frank I. Davis, former Bellefonte resident and taxi operator, who died suddenly Tuesday afternoon previous at his home in the Millheim Narrows. Rev. J. J. Weaver officiated. Interment was made in the Millheim cemetery. Mr. Davis operated an eating stand at the Grange Encampment and Fair for a number of years. He lived for the greater part of his life in Bellefonte. A few years ago he built a cottage in the Millheim Narrows, where he had lived since. Death was attributed to a heart attack while he prepared to go to the polls to vote late Tuesday afternoon. YOUNG.—Mary Fietta Young, widow of Robert Young, died at her home in Millheim Tuesday morning of last week after a short illness, the cause of death being a stroke of paralysis which affected her left side. She was aged 89 years. Mrs. Young, a native of Madisonburg, was born in that community on August 28, 1859, a daughter of John and Elizabeth (Roush) Rachau. Mr. Young to whom she was married in 1892, passed away about twelve years ago. Surviving are two sons and a daughter: Milton I. Guiser, of Aaronsburg; Russel Wolfe of Akron, Ohio; and Dorothy, wife of Lester Crabb of Millheim. Also surviving are three sisters and a brother: Mrs. Elizabeth Bartley of Spring Mills; Mrs. Minnie Smetzler of Green Springs, Ohio, and Mrs. Annie Helfrich of Bellefontaine, Ohio, and Lewis Rachau of Clintondale. She was affiliated with the Reformed church and Rev. Frederick Griesing conducted services at the home Friday afternoon, and continued in Millheim Reformed church. Interment was made in the Fairview cemetery at Millheim. REITER.—Mrs. Sarah Anne Reiter of near Woodward died Tuesday night of last week at the John Hubler home in Brush Valley of complications due to advanced age. She had not been in good health for some time. Mrs. Reiter was born in Clearfield county October 4, 1853, a daughter of Adam and Leah Foreman Jordan. Her husband, Isiah, died a number of years ago. NATIONAL GRANGE IN SESSION AT PEORIA, ILL.

On Wednesday of this week, at Peoria, Illinois, the National Grange opened its 73rd annual session with a large attendance of rural people and 36 organized states represented by delegates. At two o'clock in the afternoon National Master Louis J. Taber of Columbus, Ohio, gave his annual address. Mr. Taber is the recognized spokesman of organized agriculture, with the Grange the oldest and largest farm group in America. Mr. Taber strongly put the Grange on record as opposed to American interference in European turmoil and very timely is his plea for "preparation for peace," as related to the conservation of our own natural resources and the preservation of good moral, practical education and the truly American way of living. While by no means endorsing many of the so-called "farm relief" experiments of recent years, Mr. Taber's constructive address, urged the hearty mobilization of all the forces of government, industry, labor and agriculture in a common program of national unity. He also warns of the dangers of regimentation, extravagance and indolence, and the address as a whole is a clarion call of the support of America's best.

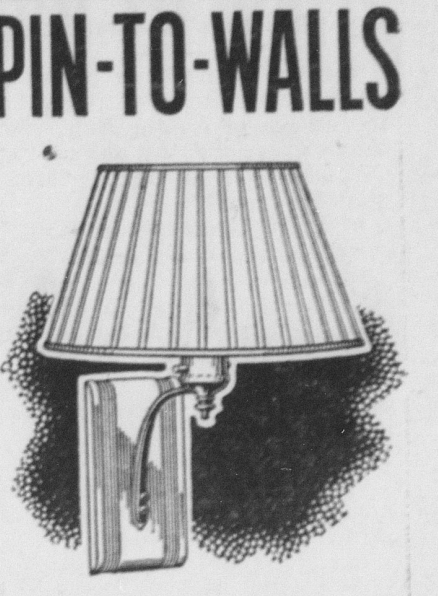
DECAYED LEAVES FORM VERY VALUABLE HUMUS

Burning leaves raked from the lawn is like burning dollars, warns County Agent R. C. Blaney, who claims that thousands of dollars in soil improvement values go up in smoke with the wholesale burning of leaves. Decayed leaves provide soil with valuable humus. Humus in the soil not only helps to make it more easily cultivated and keeps it in good condition for plant growth, but it also helps to hold moisture in the ground. This aids in preventing dry weather injury to growing crops. A ton of dry leaves contains as much organic matter as three tons of ordinary farm manure, and decayed organic matter or humus is the basis of any good soil. The decay of the leaves can be hastened by raking them when wet. Then place them in a broad, flat-topped pile in an out-of-the-way place or corner of the garden. If it is necessary to rake leaves when dry wet them thoroughly as they are placed in the pile. Rapidity of decay can be hastened by adding a mixture of five parts ammonium sulfate, four parts ground limestone, and two parts superphosphate at the rate of one pound of the mixture per 40 pounds of very wet leaves. Equal parts of ground limestone and such complete fertilizers as 4-12-4 or 5-10-5, as commonly used on home gardens and lawns, may be mixed with the leaves at the rate of 50 to 60 pounds per ton of leaves. The humus which is formed will be greatly improved by the addition of one of the fertilizer mixtures. REGISTER'S NOTICE.
