CO. JAIL FOR BEATING,
ROBBING, GARAGE OWNERIn the Centre county jail are four
youths awaiting court action on char-
ges of assaulting and robbing a gar-
age owner in Philipsburg Friday
morning. The boys were captured at
Utahville, Clearfield county, after a
wild chase through Philipsburg
streets and snowy highways in that
area.They are Robert Bendyk, 20, Frank

Nick Muhaw, 22, and Alex Dawson,

DELEGATE-AT-LARGEPetitions are being circulated this
week throughout Centre county for
Edward Jackson Thompson, Philips-
burg attorney, who was named as a
delegate-at-large to the Democratic
Party's presidential nominating con-
vention to be held in Chicago on
July 15.Mr. Thompson was one of the 16
men and women chosen from the
ranks of the Pennsylvania Demo-
cratic party. The selections were made
on Monday at Harrisburg by the
Democratic state committee. In 1932
and 1936 Mr. Thompson was a dis-
trict delegate to the Democratic na-
tional convention.Ex-Senator Thompson was the only
resident from the Central Pennsylv-
ania section chosen to the delegate
at-large post.Other delegates included State

REFUSES TO RESIGNAnother school district battle raged
in Centre county last week as
superintendent Earl K. Stock of
Bellefonte refused to resign his po-
sition after the Centre county seat
school board had voted 3-2 to ask for
his resignation.No reason was given by the school
board in voting for Stock's resigna-
tion and the superintendent principal
said he would hold on to his job
without a reasonable cause given for
demanding his resignation. Stock
explained that when a representa-
tive number of Bellefonte residents
demanded his resignation he would
resign his post.The three Bellefonte school board
members who voted for Stock's resi-
gnation even refused to give another
school board member who voted
against Stock's resignation any reason
for the attempt to oust the prin-
cipal.Stock has been affiliated with the
Bellefonte schools for the past twenty
years. A short time ago school
teachers gave him a testimonial din-
ner in honor of his 20 years of serv-
ice.

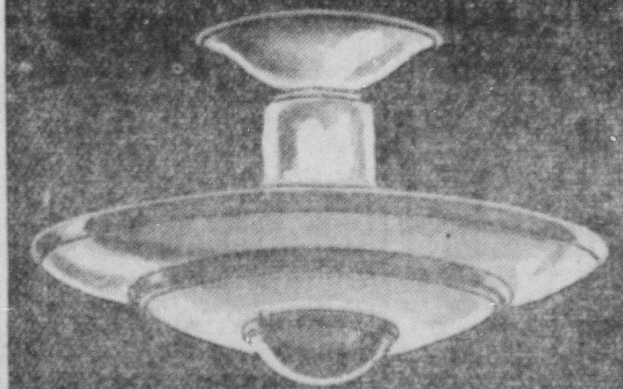
A "FEW" TONS OF COAL

More than one-third of a million
tons of coal, to be exact—361,994 tons
—was the output of Centre county
coal mines during the year 1939. An
average of 842 men were employed
in the mines, according to an official
report made by W. G. Knapper of
Philipsburg, mine inspector for the
5th bituminous inspection district of
Pennsylvania.Easily the largest production in
Centre county was that of the Lehigh
Valley Coal company, with 124,693
tons and employing 195 men. Second
largest producer was Edna Pools,
Inc., with 24,347 tons, and third was
the Banner Coal Co. with 23,999 tons.

Coburn Man Injured In Accident

Wm. C. Crader of Coburn, coming
through Pleasant Gap late Tuesday
afternoon of last week, was seriously
injured when his car skidded and
struck a tree near the south end of
the town, says the Millheim Journal.
Striking the tree broadside, it is
said the car had the appearance of

some giant. The vehicle is probably
a total wreck, although Garageman
Charles Miller brought it down to
the Stover garage at Spring Mills,
