Many are wont to look upon Farming as the simplest of all arts; requiring nothing more than strength to dig and hoe, and a little common sense to plant and reap. The idea that a good education is any degree required, is by many entirely lost sight of; that if a man only possesses strong limbs and a stout constitution, he is all that is required to make a good farmer.

Many farmers' sons, as soon as their education becomes more extended or varied, consider the farm a field for the development of their talents, and seek the higher professions (in their opinion) of a lawyer, a doctor, or a divine; being content to be a fourth or fifth rate preacher, doctor or lawyer, sooner than become a practical and useful farmer. So long as this error is not corrected, the soil will be left to those who possess strong limbs and empty skulls. Just so long will it be held in a lower esteem than other professions. But why should it be?

In a society like this what pursuit can a man follow more ennobling and honorable than farming? If there is any pursuit in life more closely connected with science than another, it must be agriculture. The works of the soil are the works of science meet his observation every day, and are made to play a part of the various labors which he is daily engaged in. The science of Chemistry, for example, is not only employed in the preparation of manure, but also in the selection of the best seed, and in the treatment of the soil.

An interesting question, defining the relative powers and duties of Church Sessions and Boards of Trustees, under the Presbyterian Form of Church Government, has just been decided by Judge Pierce, of the Common Pleas of Philadelphia. The Walnut Street Presbyterian Church proposed several amendments to its charter, which were referred to the Session.

The said Trustees shall have power to appoint an organist (subject to the approval of the Session), and also any other persons they may think necessary for the service or convenience of the congregation, and to pay their salaries.

The congregation had become divided in sentiment on the subject of employing a paid choir, and exceptions were filled to the amendments on the ground that the music of the church was a part of the worship of God, and should be subject to the control of the Session; that the Trustees, whose duties relate exclusively to the temporal affairs of the church, ought to have no voice in the selection of any choir.

It will be perceived from these standards of authority that in the Presbyterian Church the spiritual government is vested in the Session, including the public worship, is committed to the Session, and the Session is to be guided by the laws of the Church, to minister and church session. A majority vote of the Session is sufficient to control the public worship in its own branch of the church, and to determine the manner of its conduct.
