Cleaning Oilcloths. Oilcloth is ruined by the application of lye-soap, as the lye eats the cloth, and after being washed it should be wiped perfectly dry, or the dampness will soon rot it. If laid down where the sun will shine on it, much, it will be apt to stick fast to the floor, unless paper be laid under it.
