

DESTRUCTIVE FIRE! HEAVY LOSS OF PROPERTY! Last night at a quarter before 10 o'clock, our citizens were startled by the cry of "fire!"

The fire originated in a small frame stable, belonging to the St. James Hotel, on the corner of Second and Chestnut streets; and with such rapidity did the flames spread, that within a few minutes the fire had reached the main building.

Both on Second and Chestnut, in the alleys adjoining, and Mulberry street below, there was an extraordinary busy scene, in the efforts to save the property owned.

Mr. Samuel Myers, at the corner of the alley, had a shoe store, with a stock worth \$2,000. Building was nearly destroyed. He had an insurance of \$400.

Mr. Ludwig Wetz, baker, lost some fifteen barrels of flour, meat, furniture, etc., altogether some \$500. The building belonged to the British Hotel, and was sold some two weeks ago by Mr. C. Eberly.

Mr. John Jauss, house and furniture destroyed and broken. The loss is about \$2,000. Insured for \$1,000.

Mr. Peltor, a tenant of Mr. Jauss, lost every thing in his house valued at some \$200.

Mr. Lucas Koenig, brewer, whose whole premises were in imminent peril, is indebted to the insurance company \$200, for his safety.

The Presbyterian Church, which was totally destroyed, was insured in the Pennsylvania and Franklin Insurance Co., at Philadelphia, for \$7,000.
