"No execution or other process shall issue against an officer, non-commissioned officer or private of the militia, when called into actual service, under a requisition of the President of the United States, or in pursu-President of the United States, or in pursuance of the orders of the Governor of this Commonwealth; nor shall any such process issue against him until thirty days after he shall have returned from duty, to his usual place of residence, or until forty days after he shall have been discharged; and the court, alderman, or justice of the peace from whom any such process shall have issued, shall quash the same, as soon as the fact of any such person being ordered on public duty shall have been proven; and all the costs which shall have accrued in commencing or conducting any such process shall be paid by the persons who shall have applied for the said execution or other process."

1 A very important movement has been made in Virginia, which threatens the division of that State on the secession question.
