The Gettysburg Spring.

The Gettysburg Springs have at length been fairly pitted against their most celebrated contemporaries of the old and new worlds.

This has happened in this city, in a case of rheumatic gout, on which not only the most famous foreign and domestic mineral waters, but the whole resources of the medical profession have been vainly tried.

This single case is likely to do more for Gettysburg than all the big Comenities, and blustering pretensions of negotiators who have figured in connection with the springs, disgracing themselves, and mortifying the people of Gettysburg.

Pennsylvania Products.

The three great staples in the production of which Pennsylvania is pre-eminent, are coal, pig iron and petroleum. The immense extent of the industries involved in these products, and the enormous value to which each of them has risen in late years, are chronicled in the report of the Board of Trade for 1866 just published in Philadelphia. The product of coal in Pennsylvania during the year is estimated in round numbers at 16,000,000 tons, or one fourth more than in 1865; and its value at the markets of the year is given at nearly 90,000,000 of gallons, valued at over \$47,200,000. The product of pig iron during the year is given at 640,000 tons, valued at over \$81,000,000. The aggregate value of coal, petroleum and pig iron, for the year, was \$158,281,243. The Press, in speaking of the great value of these resources, which, in the present industrial development of the country, may almost be considered peculiar to Pennsylvania, remarks: "Our coal product is worth as much as the gold product of the Pacific States, and our pig iron and petroleum yield yearly a richer revenue than was ever obtained from the famous silver mines of Mexico and Peru." We are sure the Pennsylvanians are justified in boasting of the gigantic growth of these profitable industries. When they can take from the bowels of their State in one year articles valued at nearly one hundred and sixty millions of dollars, besides all the vast agricultural and pastoral productions of its surface, they must be allowed the credit of a rich inheritance and a resplendent domain.
