

ARTICLE XIL OF NEW COUNTIES.

There shall be an additional article to said

corporation, association institution, or party SECOND AMENDMENT.

No county shall be divided by a line cutting of over one-tenth of its population, (ei.h. er to form a new county or otherwise.) without the express assent of such county, by a vote of the electors thereof; nor shall any new county be established, containing less than four handred square miles.

THIRD AMENDMENT.

From section two of the first article of the constitution, strike out the words, "of the city of Philadelp ita, and of each county "respectively;" from section: five, same article, strike out the words, " of Philadelphia and of the seceral counties;" from section seven, same article, sinke out the words, "noither the city of Philaddphia nor any," and insert in lieu thereof the words, "and no;" and sinke out section four, same article; and in lien thereof

insert the tohowing: "SEC. 4. In the year one thousand eight hundred and sixty-lour, and in every soventh year thereafter, representatives to the num-ber of one handred, shall be apportioned and distributed equally, throughout the state, by districts, in proportion to the number of taxable inhabitants in the several parts thereof; except that any county containing at iteast, three thousand five hundred taxables, may be allowed a separate representation; but no more than three counties shall be joined, and no county shall be divided, in the formation of a district. Any city containing a sufficient number of taxables to entitle it to at least two number of taxables to entitle it to at least two representatives, shall have a sepirate repre-sentation assigned it, and shall be divided in-to convenient districts of consignous territory of equal taxable population as near as may be, each of which districts shall elect one repre sentative."

At the end of section seven, same article, insert these words, "the city of Philadelphia shall be divided into single senatorial districts, of contiguous territory as nearly equal in tacbe devided in the formation thereof."

The legislature, at its first session, after the The legislature, at its first seation, after the adoption of this amondment, shall divide the city of Philadeiphia into senatorial and rep-resentative districts, in the manner above provided; such districts to romain unchanged antil the apportionment in the year one thou sand eight nundred and sixty-four.
