Remarkable Phenomenon—Immense Swarms of Strange Insects.

A correspondent of the New York Evening Post writing from Poplar Ridge, N. Y., under date of Sept. 24, gives the following remarkable statement. He says:

Yesterday, at about four o'clock P. M., the atmosphere became suddenly filled with myriads of insects of a type entirely unknown to this region, as far as I can learn. The phenomenon is known to have extended several miles, and appears to have occurred at the same moment. The insect is about one-fourth of an inch long, closely resembles the common ant.

But the strangest part of the matter (that is, to me,) remains to be told. As soon as they appeared, they began to fight upon whatever object they came in contact with, and to give birth to young insects ready winged, which in a few seconds ascended into the air, while the old ones threw themselves into violent contortions, which continued until they succeeded in ridding themselves of their wings—after they appeared much relieved, and ran briskly about upon the ground, as contented, apparently, as though they had never possessed the power of flight.

In an hour the earth was covered with these fallen insect-angels, and strewn with their lifeless wings, while their tiny, new born progeny, had ascended, and were sporting in the beams of the evening sun. This morning the parent insects may be seen scuttling among the grass, or whatever offered protection for the night, while the new generation appeared dormant upon the surface, awaiting the warming rays of the rising sun.

Telegraphic News.

From Utah—The Mormon Difficulty only postponed, not settled.—The Pike's Peak Gold Mines.

LEAVES WORTH, Sept. 15, via Roanokeville, Sept. 17, per U. S. Express Co.—A number of officers from Utah arrived here today, among whom are Col. Alexander, and Lieuts. Grover and Mansfield, of the Tenth Infantry, and Capt. Marey, of the Fifth Infantry. They bring no news of importance.

It seems to be the general impression among the officers that further trouble may be expected with the Mormons, and that the difficulty has only been postponed, not settled.

A train of twenty wagons leaves here tomorrow for Pike's Peak, and Mr. Wm. H. Russell will start a train of forty wagons in a few days.

A number of gentlemen are here from the surrounding counties, preparing outfits for companies to the mines.

WASHINGTON, Sept. 19.—The Charleston Courier of yesterday states that twenty-five of the Africans captured on board the slave Echo, have died since their arrival.—Two of the crew are also dead.

NEW ORLEANS, Sept. 18.—A duel was fought to-day between Mr. Wood, of the True Delta, and Mr. Barlow, formerly of the same paper. There were three rounds discharged with rifles; but neither being hurt, further operations were suspended.

MONTREAL, Sept. 19.—A despatch from River du Loup, at 6:30 P. M., states that the steamer North Britain expected from Liverpool with four days' later news, had not been signalled below.

St. Louis Sept. 19.—The first overland California mail to California via Jefferson City and Springfield, Mo., Fort Smith, Arkansas, and Preston, Texas, took its departure from the St. Louis post office this morning. It goes by the Pacific Railway to Tipton, Mo. thence in coaches and spring wagons to San Francisco, the fare from St. Louis to San Francisco being \$200.

ADRIAN, Mich., Sept. 17.—Mr. Thurston, the aeronaut, who was carried off by his balloon was seen at quarter past one o'clock, P. M., at a great height, in the direction of Malden, Canada West, as ascertained by compass-bearing by the parties observing him. After Mr. Baumsler his companion had alighted, the basket and netting were removed, and the balloon inverted to precipitate the escape of the gas. Mr. Thurston was holding on to the uninflated portion, seated on the valve-board, when it ascended with him.

RICHMOND, VA., Sept. 17.—A duel was fought this morning near this city, between O. Jennings Wise and Sherrard Clemens. Clemens was wounded in the thigh. The cause of the difficulty was the recent comments in the Enquirer, on Mr. Clemens, relative to the gubernatorial question. Mr. Clemens was the challenger.

THE SCOURGE.—The yellow fever now prevails in four of the leading cities of the South—namely, New Orleans, Charleston, Savannah and Mobile.

PROF. GEORGE COMBE, the Philosopher Phrenologist died in England a few weeks ago. He was born in Edinburgh Scotland in 1788. He came to the United States, in 1830, and remained until 1840 lecturing on Phrenology, and preparing his journal.

MARRIAGE IN HIGH LIFE.—A correspondent writes from Stonington, Ct., Aug. 23, as follows:—

Baron Limbourg, the gentlemanly Ambassador from the Netherlands, and Miss Cass, daughter of the Democratic Secretary of State, were united in holy matrimony this afternoon by the Rev. Mr. Weston rector of Calvary Church, Stonington.—The old gentleman was present, and gave away the bride. The ceremony was marked, at least inside the sacred walls, by the absence of all display—quiet and plain, becoming to sensible folk. The nuptials over, the party returned for a little while to the Wadawunk House. The General in the meantime vented his way on foot to the depot, where, soon after, came the happy bride and bridegroom en route for Newport, and, after a few minutes conversation, he bade them a fatherly farewell.
