WASTE IN THE ARMY.—To learn how immense is the army of the United States, it is necessary to examine the rolls at the Paymaster's Office. A correspondent of the Cincinnati Gazette, indignant at the discoveries there made, says:

One thing ought not on any pretext be neglected. A peremptory stop should be put to the further saddling of the country with a plethora of officers. We have on the rolls, say an army of 700,000 men, of whom perhaps half a million are in some sort or other in the field. We are paying officers for not a man less than fourteen hundred thousand! A colonel is popularly supposed to command a thousand men. Our colonels will hardly average 500! The same may be said of all subordinate officers.
