

DEATH OF A ROPE DANCER.—Madame Saqui, a rope dancer, whose fame dates from the beginning of this century, died in Paris in January, in her eightieth year. It is recorded of her that on the occasion of the birth of the First Napoleon's son, the King of Rome, she offered to dance on a rope between the two towers of Notre Dame. Napoleon refused to allow the exhibition. Subsequently she appeared, in defiance of the Emperor's prohibition, on her rope, in the midst of a display of fireworks—a feat then novel, and one which excited the utmost astonishment. When she heard that the Emperor was in a great rage at his command having been disobeyed, she said, "Tell him to give orders to his grenadiers, and let us risk our lives as we like, for our glory." She made a large fortune at the little theatre on the Boulevard du Temple, which for many years bore her name, and afterwards became the Delanceys Comiques, and then purchased with her savings Voltaire's house and grounds at Ferney, but was very soon obliged to sell it, and during the latter years of her life was in great poverty. Only four years ago she danced at the Hippodrome, where, at the age of seventy-six, it was a wondrous but sorry sight to see her.

THE GOSPEL IN NEW ENGLAND.—The Independent speaks of the decline of the gospel, or rather of an interest in the same, in the State of Connecticut. It seems that a large number of churches are without congregations, and that the pay of the clergymen is so paltry as to be little above a starvation scale. That an interest in religion in all the New England States should become slack, is not at all surprising, when we consider the lengths to which the pulpits there have been prostituted to base and miserable partisan service. It is not from the lack of a sincere religious sentiment that these churches have been deserted. It is because the congregations have become disgusted with political parsons and with their radical harangues, and unless the evil be reformed altogether we fear the spread of religious feeling in New England will be very much restricted. Now that the rebellion is over and the country saved, it is to be hoped that our country parsons will turn their attention to saving the souls of sinners, and leave the mire of politics to be dabbled in by those whose affinities incline them that way.—N. Y. Herald.

MURDER.—By advices from San Francisco, California, we have the sad news that Gen. T. G. Pomeroy, formerly of this city, has been brutally murdered, and his remains found on a mountain near the town of Oakland. Mr. Pomeroy had been missed for some time, and no clue could be obtained of his whereabouts. He had gone to California to purchase some lands for a Philadelphia mining company, and was known to be in the enjoyment of good health when he left for his destination. Gen. Pomeroy was well known in this city, where he had a host of warm personal friends. In connection with O. Barrett, he was one of the publishers of the PATRIOT & UNION for several years. He wielded a brilliant pen, and his articles always bristled with original points and witty sarcasm. Mr. Pomeroy was about fifty-five years of age.—Pat. & Union.

AN EMINENT LADY.—The Charleston papers announce the death in that city, on the 15th instant, of Miss Harriet Pinckney, the second daughter of General Charles Cotesworth Pinckney, one of those grand old men of '1776, who, with tongue, as well as pen and sword, inscribed his name high on the roll of fame. He was not only the companion-in-arms of Washington, but won for himself the distinguished appellation of "the friend of Washington." The deceased was also eminently allied on the maternal side of her house, her mother being a daughter of Henry Middleton, a signer of the Declaration of Independence, whose esquire, when living, was without a spot, and whose name must ever be held in universal esteem and honor. The deceased was upward of 90 years of age at the time of her death.—N. Y. News.
