The Democratic Primary Election will be held in the several Election Districts of this county on Saturday, the 11th day of June, 1892, at such hour as shall be agreed upon by a majority of the Vigilance Committee of each separate district, and to close at such hour as such committee shall name, for the purpose of expressing by ballot their choice of candidates for the following offices, viz: One person for Assembly, one person for Sheriff, one person for Commissioner, one person for District Attorney, one person for Auditor, one person for Jury Commissioner, and one person for Coroner to be elected in October, 1892.
