Fitch, Republican member of Congress for Nevada, in order to secure his own re-election, imported into his State some four hundred Mormons to vote the Radical ticket. The saints, however, went back on Fitch, and voted the straight Democratic ticket. Fitch is permitted to stay at home by two hundred majority.

Ex-Governor Wilson Lumpkin, of Georgia, who died lately at Athens, in that State, at the advanced age of eighty-eight, was probably the oldest living ex-member of Congress. He was a member of the House of Representatives, as far back as 1816—fifty-five years ago. This must be ten years before the venerable Thomas Ewing, of Ohio, entered Congress, whom we had previously supposed to be the oldest.

Instead of it the Radical house, out of deep regard for the memory of the man who never was known to neglect a public duty, has adjourned for ten days.

DRIFTING.—There is now a bill before Congress which provides for the establishment of a system of national education, taking from the States and placing in the hands of a few men, to be selected by the President, the control of all the public schools of the country. It would give these men and the President the power to employ the teachers, purchase lands, construct school-houses, describe the books to be used, &c. This is about the boldest and most dangerous step yet brought up. The reader will at once perceive its drift.

GOE BACK ON HIS FRIENDS.—Horace Greeley has thrown his "Maine lawism" overboard. He declares now that he does not believe in prohibitory laws, and plants himself on the solid ground of moral suasion, where all the victors ever gained for temperance have been won. This declaration will no doubt astonish the Tribune readers, who have been accustomed to look upon Mr. Greeley's prohibitory principles as among the firmest and most exalted in his schedule of reforms. Others will hear of his retraction with contempt. The "old philosopher" has been weakened and divorced from more firm than almost any other man in the country. It is his habit to champion a cause and then desert it.—Bridgeport Farmer.
