Mr. Barnum's original pro-position was that he should offer the reward, and, if the boy was secured, some arrangement should be made for ex-hibiting him, by which Mr. Ross should have a large share of the profits, and thus, perhaps, restore his estate of \$60,-000 which he had spent in the search. Mr. Ross made no answer at that time, but returned to Philadelphia to consult with his wife and her brothers, who are wealthy, and met Mr. Barnum in the Haynes House Siturday to accept the offer, with the condition that, if the boy is found, it shall be discretionary with the family either to r-incluse Mr. Barnum or arrange for the child's exhi-bition. 
