After a humorous selection read by Miss Julia A. Coyle, of Nesquehoning, Dr. N. C. Scheffer, of the Kutztown Normal School, stepped before his appreciative audience. His lecture embraced the period between the close of the Revolutionary War and the adoption of the Constitution; a period which is commonly passed by with only a few sentences in common school histories. The plainness and the simplicity of his speech, as well as his extensive treatment of his subject, are commendable features of this lecture. After the lecture and an exercise given by two pupils of the Lehigh schools, the audience dispersed.

On Saturday morning at the appointed hour the High School room was filled to its utmost seating capacity with teachers and others interested in the progress of education. The Superintendent, perceiving that this room did not afford accommodations for the constantly increasing audience, gave notice that the institute would adjourn to the Hall.

After prayer offered by Rev. Steinbitz, of Lehigh, and singing by the members of the institute, organization was effected by electing Supr. T. A. Snyder, President; Prof. C. A. Ritter and H. A. Eisenhardt, Vice Presidents; Messrs T. L. Wentz, A. J. Ballist, H. A. Keiser and G. G. Watkins, Secretaries.

Prof. C. A. Ritter opened with a talk on "Object Teaching." He began by saying that every educational age is characterized by its "fashions." Years ago Mental Arithmetic was the idol of educators. This was succeeded by the drawing class and by object or concrete teaching, which now in this era of the new education, holds the foremost position in the curriculum of common school studies. Its importance can be substantiated by the fact that the successful men of the world, are those whose perceptive faculty has been developed. Prof. Ritter would prescribe such a course, a proper observation of the things which are brought out the fact that the order of the development of the mental faculties is thus:

The pre-entative power, first; the representative power, second; the reflective power, third; and the intuitive power, fourth.

The primary object of such lessons is to enable the child to form a correct mental conception. The teacher, by the use of objects, will secure attention and train the child to habits of attention, develop perception, cultivate memory, imagination, language, and in addition to all this important valuable general information. The instructor proceeded to illustrate with an application to the teaching of fractions.

The time intervening between this and the next exercise was used by Supr. T. A. Snyder. He fully agreed with the speaker, and took an opportunity to express his sincere appreciation of the efforts of the institute, the most largely attended, and in all probability the most successful local institute of Carbon county.

Prof. Stetler having concluded, it was understood that the institute would be dissolved. Supr.
