The authorized strength of the army is now 17,894 men. The actual strength at the date of the returns, July 1, 1856. was 15,562. The number of enlistments made during the twelve months ending September 20, 1856, was 4,440. The number of offers refused on account of minority and unfitness for service was 5.594. The number of casualties during the same time was 6,696 of which 3.223 were by desertion.
