

THE LATE GEN. TORBERT. Obsequies in New York City. New YORK, Sept. 29.—The remains of Gen. Alfred T. O. Torbert arrived here this morning from Florida, on the steamer Western Texas. Under escort they were conveyed to the city hall, where they lay in state in the governor's room until ten o'clook. The governor's room was heavily draped in mourning. The casket contain-
