The residence of Henry Copenhefter, in West Hempfield township, was forcibly entered by burglars last night and a considerable amount of property carried off. A Waltham (silver) watch, numbered 838,094, and purchased from Edward J. Zahm, of Lancaster; about \$100 in money, a lot of clothing, silverware, etc., were among the articles which the thieves succeeded in getting away with. More that two hundred dollars, which was locked up in the drawer of a desk was not discovered by them, and after littering the floors of the house with articles of all descriptions the noise with articles of an de-scriptions they got off. 




