But the fact is that the course which Arthur is advertised to pursue is just the one that would be naturally followed by a man who would have been wicked enough to use Guiteau as a tool of his ambition. If he had been vile enough to inspire the murder he would be cruel enough to unhesitatingly hang his instrument; and be glad to do it beside to-day.
