Stewart and John Hager, of this city, W. Fred Reynolds, of Bellfonte, Pa., Roseville Michel, of Easton, Pa., and Edmund Conyngham, of Elizabeth, N. J. Next came the bridesmaids, Miss Helen H. Stewart of Wausau, Wis., and Miss Edith Conyngham, of Staten Island, N. Y., attended respectively by the groomsmen, Messrs. Henry L. Michel, of Easton, Pa., and Dr. James Mitchell, of the Philadelphia hospital, brother of the bride. Then followed the maid of honor, Miss Martha Graham Mitchell, sister of the bride, Mrs. Mitchell and the groom and the bride leaning on the arm of her father bringing up the rear. Arrived at the head of the aisle, the bride separated from her side, forming an open column through which those to the rear passed forward. The column then closed around the contracting parties during the performance of the ceremony. Dr. Mitchell, the bride's father, pronounced the pair one according to the solemn ritual of the Presbyterian church, after which the party left the church in reverse order from that in which they had entered.

The bride was arrayed in the white silk dress, veil, orange blossoms and apparel worn by her mother on her bridal day, of which event last night's occasion was the twenty-fifth anniversary. **RAILROAD ACCIDENT.**  
Cars Capsize and Train Detained.  
About half past 4 o'clock this morning, as the second empire freight train west was coming into Lancaster via the end road, it was run into by a freight train going east on the new road, at the junction of the two roads just west of the Big Conestoga bridge. The locomotives of the east bound train struck the fast car and caboose of the west bound train and upset them, tearing up the tracks and blocking up the road for some time. The news express west and the fast line east were detained for some time, but no one was hurt by the accident.

### Fall of a Cylinder.

What might have been a very serious accident occurred last evening. ### COURT OF COMMON PLEASE.

BEFORE JUDGE PATTERSON.  
Upstart the ejection suit of Eabling vs. Eabling, is yet on trial. The defense concluded their evidence by offering a deed, which is in the possession of plaintiffs, conveying this property from Jacob Eabling to the defendant. This plain object was to, but it was admitted and read.

The plaintiff in rebuttal then proceeded to show that in accordance with an agreement made between Jacob and Benjamin Eabling in 1876 to exchange properties, a deed was made by B. F. Flickinger, but the whole amount of money not being paid no assignment of the property was made, although Benjamin was allowed to occupy the land. His claim was therefore vitiated and illegal.

The testimony closed at noon and counseled began speaking this afternoon.

Before Judge Livingston.

O. B. Guiney was Robert Warden, the plaintiff, who was a merchant in Fullerton township in 1876, and he brought this action for damages. It was alleged that in June, 1876, the plaintiff made a parol contract with defendant to purchase a property, consisting of a tract of land with buildings situated at Eldora station, on the Peach Bottom narrow gauge railroad. The consideration was \$50 and the assumption of a debt of \$300 due Davis McClure for lumber, which was furnished for the erection of the building on the property. In 1878 the plaintiff demanded the fulfillment of the contract by Warden. The latter refused and this suit was brought for damages.

The defense was that at the time when plaintiff asked for the consummation of the contract, he had not paid any of the purchase money nor the debt to McClure, although he had been sued as one of the parties who had purchased the lumber, and had paid his one third of the amount with costs of suit. The defense, contended therefore, that plaintiff could not recover on trial.
