A dispatch from Hong Kong says news has been received from Hai P'ong, announcing that a force of three thousand Chinese troops made an attack on Hai River on the 17th instant. The French garrison, supported by a gunboat, the River Tai Bigne, held out from nine o'clock in the morning to four in the afternoon, when the Chinese retreated. The loss of the French was twenty killed and wounded. The French gunboat had its hull pierced by the enemy's shot in several places and eight of the crew were wounded. The fight lasted seven hours. Admiral Peyron, minister of marine, has received a dispatch from Admiral Courbet, commander of the French forces in Tonquin, stating that all the available troops have been concentrated at Ha Noi, in order to begin operations. Sufficient garrisons have been left to defend the other cities of the delta. A telegram from Saigon says that the French began operations in Tonquin on the 25th instant. A dispatch dated the 26th states that news has been received from the north of China that a secret treaty exists between the Chinese government and the Black Flags. The same dispatch says that Chinese reinforcements continue to arrive at Canton and that war is regarded inevitable.
