Butler's Proclamation.

General Butler addresses a very long discourse to those whom he styles his constituents, which purports to give an account of his stewardship in the several matters, pertaining to the rights of man, which he conceives to have been especially placed, by the Almighty and himself, in his charge.

General Butler, as has often been remarked, is a very unique man. He has never been surprised in assumption by anyone of whom he heard. His unapproachable self-esteem and self-sufficiency have made him the most egotistical man in the country.

It has passed through its periods of fear and hatred and admiration for him, and sees the general as an amusing political acrobat, who has lost nothing of his agility with his increasing years, but rather has become more nimble in his movements as the time for his success wanes for him.

Those who have time to read his proclamation will perhaps find out the reasons which Butler assigns for his candidacy. He certainly speaks them out sufficient length. We have not ourselves had time to read through his statements; a glance at them has sufficed to convey their purport, which, indeed, was easily to be imagined.

General Butler is cunning, and bold, and brassy; characteristics in which he has an eminent rival in Blaine. It is probably a lure of this kind that has drawn Butler on; or, perchance, simply the love of notoriety, which is insuppressible in his soul.

General Butler, obviously tall man, is not a great man. He is smart and bright and forceful, but not honest, conscientious or wise. He would rather in his tell the truth and rather cheat than pay in his present attitude he stands pre-eminently alone without party or helpers. His address is in the Napoleon street—The state, it is said, is moving, says Butler, is moving; I am the soul of this reform. The exercise of proper government is represented in me. This party is Butler's party and this country is Butler's country; if Butler's party wins, it is the party of the New York Sun, it is the promised fulfillment of the Butler party. He assumes to declare Butler a great, honest, and sincere man, finding in him all those virtues which have been to all others conspicuously absent in his character, from the time he voted alone for Jeff Davis at Charleston to the time he proclaims for Ben Butler alone at Lowell.

JOHN A. LOGAN is not covering himself with great glory in his tour through western New York, and the speech making which is his chief incident. Talking is Mr. Logan's strong point. He can talk everlastingly; and his talk sounds reasonably. His orations probably have the ring of the real thing and those who hear him doubtless think the orator is in fact saying something. They cannot recollect what it was when they go home to tell their people about it, though it sounded so fine; and the general would get away from New York with the reputation of being a powerful talker, if it was not for the shorthand reporters of the newspapers, who wait on him as a vice-presidential candidate to take down every word he says; and they have just ruined the general's reputation. The thing has got so bad that it may be necessary to call him in off the ticket and substitute a man of less twisted speech. If Logan is hurried away into retirement, this said necessity may be avoided; but nothing will save him if he is kept out. The continued appearance of his speeches in cold type will be worse for his party than an attack of Asiatic cholera. No party can stand hearing its candidates made sport of; and General Logan is evidently not to be loose without his wife where his speeches are wanted. Mrs. Logan has gone to West Point to take care of a sweetening son and her own husband's made the game of the grand reporters. The general is not worse than a good many men who get along with the aid of God, and who get along swimmingly until their orations are unfortunately printed. It is astounding then to see what nonsense men talk and what English they clothe it in. But this is a world of false pretenses and oratory is not the only thing in which it appears. The fools of the Logan type have the world pretty well by the ears.

BENNY BUTLER ACCEPTS.

THE DEMOCRATIC STATESMAN WITH COURAGE TO TAKE HIS OWN PART.

General Butler has accepted the nomination for the presidency, and has addressed a letter to his constituents, some of the more striking points of which are reproduced.

In compliance with oft-repeated and anxious inquiries, I hasten to give account of my stewardship of the public trusts with which I was charged. They were four: First, hostility to all monopolies in commerce, industries and lands.

Second, the preservation of the national legal currency of the people, and the maintenance of the gold standard. Third, the needs of all men and women who labor in the production of wealth to be protected against the encroachments of those who absorb and consume without producing.

Fourth, the necessity for reform and correction of abuses in government, so that its presence on the people would be made as light as possible; its administration active, to guard the rights of American citizens at home and abroad; its make public service, individual or corporate, subservient to the use and will of the people only, so as to restore the property of the country, with spiritual, equal business, equal power, and equal privilege to all people.

I had thought if these great principles of government, by the people and for the people only, had been cordially received, and earnestly and honestly adopted by that convention as the political start of the Democratic party, the result would have been to preserve to the convention for the suffrages of the people as chief executive to administer and carry out the necessary measures, in which case I should have been bound by its terms to support its platform and program.

The Democracy and its program. The country has had no experience for nearly a quarter of a century of what the Democracy would do if they had the power, so that the people are obliged to require the most explicit pledges from their candidates before they can give their government in their hands. But the farmers and the laboring man do not know that a Democratic House of Representatives has just appropriated more money than any other body in the history of the country for the purpose of giving a free trade tariff, containing all the odious features of the present tariff, so far as regards the protection of our farmers.

Why does not know that the very fear of the action of the Democracy in enterprise and business that mills are everywhere closing, mines about to be abandoned, and our country being left a desolate waste? It is not that the machinery of the government is not working enough to support life in comfort; so that the latter, even deprived of a home market and crushed down by discriminating rates of transportation, finds it profitable to operate. It is lower than it has been in the history of the generation? Can the people tolerate that the machine Democracy has put upon a shifting, treacherous and deceptive platform?

What the Republicans have done. The country has had experience in Republican party rule twice in two years and has learned that the platform of the party is to look at its platform, for their fruits ye shall know them. At the time of the organization of the Republican party, General Butler was the party of the people, but through the action of the party, he has become the party of monopoly. From the monopoly can expect nothing from it.

True, it has in all its legislation claimed to protect and cherish American labor, but always only as an adjunct to American capital. We have had a free manufacture and other industries may only be said to be the American laborer is well paid and surrounded with the comforts of life. But how little has the greed of capital allowed of compensation to the laborer. The laborer needs only to recall to his mind his capital, sharing under even a partially fair division of its great profits with labor, has sought to relieve itself from this duty by means of justice even by the importation of foreign labor from every country whence it could be brought to the United States to the western shores of the Atlantic.

Why have they done this? Because they imported laborers and, for a time, they on our coast with the American workingman, and he can work for much cheaper, for it has ever been the rule, and if the workingman do not take the remedy for this fearful state of things into their own hands, ever will be the rule that the wages of labor are only so much, and to be increased only by the aid of labor and children in the lowest degree of comfort when all of them are at work who can work.
