The Manner in Which the "Ticket-of-Leave Man" Was Put on the Stage.

The New York Standard Dramatic company began a week's engagement in the house on Monday evening, presenting "The Ticket-of-Lenve-Man" to a crowded house. There are two ways of considering the cheap performances to which the local public are now being treated. They may be judged by the criterion of amusemenst given at the old prices that prevailed, and so considered they are very deficient. Or they may be measured by the occanic differ-ence in prices between the old and the new amusements, and here it must be honestly said that while the prices are reduced four-fifths, the reduction in the presentation is not so great. It is the confusion arising from the mixing of these two views that causes so

mixing of these two views that causes so many diametrically opposite conclusions on the subject of cheap theatrical performances. There have been worse performances at Fulton opera house than that given last oven-ing—but not many. Throughout the rendi-tion of the play the obstreperons gailery gods selzed upon every occasion offered to mercilessly guy the performers. The balance of the andience took a good-natured view of the situation, reflecting that that which is very bad dramatically becomes proportion ately good as a carliesture.
