THE PROMIBITION CONVENTION. No Amilation With Old Parties-Opposition to the High License Law, to Trusts and Monepel

The Prohibition party of Lancaster county met in county convention this morning in Excelsion hall, for the purpose of nominat-ing a county ticket and candidates for Cougrees and the state legislature and selectin telegates to the state and instional Prohibit tion conventions. The convention was called to order by

G. N. Lefevre, chairman of the county com mittee, and was opened with prayer by Dr. J. A. Martin, of Strasburg. Ezra Reist, of Manheim borough, was chosen as temporary chairman. Mr. J. O. Rohrer, of Lampeter, was
