# NOT HEARD FROM.

## THE NOULDBON OF RVOLUTION SOMEWARRE IN THE BOUTH ATLANTIC.

Three Naval Vessels Leave Brazil and Fail to Arrive at Pernambuco, Where They Were Expected to Report.

WARHINGTON, July 15.-The squadron f evolution, which salled from Rio de aneiro ten days ago, has not been heard rom since at the navy department, al-bough Admiral Walker was expected to stop at Pernambuco, which is but 1,500 s from Rio.

No anxiety, however, is felt for the safety of the squadron, as this is not a stormy period on the Brazilian coast and ships are all amply able to take care of themselves.

It is probable that the admiral found no need to stop at Pernambuco and is now sailing on to the West Indies, which he ought to reach in a few days.

[There are now three ships in the squadron of evolution, the ernisers Chi-cago, Boston and Atlanta, the gunboat Yorktown having returned to New York when the others went to Brazil. They were built partly by John Roach and partly by the government. The first cost over a million and the two last named about \$50,000 each.]


