Charter of the Lancaster Bank. We copy such portions of the charter of the Lancaster Bank as are of interest at this time. The charter was granted in 1849.

Section 14. It shall not be lawful for said bank to make or declare any dividend to the stockholders thereof, except from profits actually acquired above the par value of the stock, and no such dividend shall be made at any time when it will in any manner diminish the capital stock of said bank.

Section 22. The said assigns shall pay out of the assets and property of the said bank, in case of an assignment, the debts and liabilities in the following order: First, notes held.

Section 23. If any insolvency used in this act, shall be construed to apply to this bank when it is compelled to make an assignment, and it shall be thereupon the duty of the directors of the bank for the time being within ten days after such assignment, to file in the office of the prothonotary of the county of Lancaster a true and correct copy of the said assignment, with a full statement of its assets, liabilities, and other particulars.

Section 24. Every insolvency of said bank shall be deemed fraudulent, unless its affairs shall appear upon investigation to have been fairly and legally administered, and generally in conformity with the provisions of this act, receiving a compensation for their services as found by law to be reasonable.
