We regret to learn of the suspension on Wednesday, of the extensive railroad-iron manufacturers, Reeves, Buck & Co., and Reeves, Abbott, & Co. of Philadelphia. Their liabilities are about \$800,000, and their assets to meet for about half millions. In order to meet their liabilities of every character, these firms only ask an extension of time, and it is little doubt that this will be granted. It will be recalled that some three years ago, under a sudden and severe money pressure, these firms were compelled to suspend, and obtained an extension. Since then they have paid the whole of those obligations, principal and interest. These firms it is known, are the proprietors of the extensive iron works at Phoenixville, and employ about 3000 men, making about 100 tons of Railroad iron per day, while their payments are about \$10,000 per day. They are also the proprietors of the Safe Harbor Iron Works, in this country. It is understood that the works will be continued in operation.

The SUGAR TRADE.—The fall in the value of sugar and molasses has been great within a few weeks past. The losses on the stocks on hand must have been many millions of dollars to dealers in this country, and much more to foreign holders. The Boston *Traveller* says:

The decline from the highest point, in the probability that bottom is not yet half reached. When the decline had reached only one-half the present amount of a few weeks since, the *New York Independent* estimated that the stock of \$5,000,000 of sugar and molasses, held in that port alone, the loss was then fully three and a half million dollars. Of course it must be double that now, and if this loss is made on that stock in New York, the loss on the stocks in other quantities all over the world, and in the U. States, and the stocks on hand in the sugar exporting countries. It cannot be less than fifty millions of dollars already, and as the tendency is to continue, it will probably reach a hundred millions before the dealers will be able to touch the next crop.

Information has been received at the Methodist Episcopal Mission Rooms in this city, that there are apprehensions of a general failure in Liberia, that already several of the missionaries have returned to their homes, and that some of the missionaries on the country stations are without any other food than green plants, and that around some of the settlements the natives are cutting down the palm trees for the sake of the coconuts to sustain life. One of the missionaries there writes that this state of things has been coming upon them for years, and attributes it mainly to three causes, first, the growth of the native population, second, the want of labor, and third, the failure of the native crops several years ago, owing in part to a bad season, but mainly to the natives' general indifference upon the Dept. of Agriculture, and their dependence upon their farms. What rice has been gathered for a year or two past has not been enough for food, so they have saved some for seed.

This is a gloomy prospect, and the missionary who gives the information—the Rev. J. Horne—predicts a yet worse condition of things, and that "the end of all things is at hand." The distress does not seem to be confined to the natives; "We in the republic have been and are in a fearful condition for want of food, at some points worse than at other."—*N. Y. Commercial Advertiser*.
