THE UNITED STATES SHIP MACEDONIAN .----The Norfolk Herald, in speaking of the contemplated cruise of this noble old ship, says

"The Macedonian is 171 feet in length on her spar-deck; about 1400 tons burden; carries on gun deck eighteen 68 pounders and two 32 pounders; on the spar deck, one forward and one aft, two 10 inch guns, with solid shot, weighing I20 pounds, and shells weighing 80 pounds. Every part is creditable to our vard and to the Government. It may not be amiss to say that the Macedonian was captured in 1812 (October 25) by the frigate United States, under the command of the gallant Decatur.--She was commanded by the then Capt. John Carden, whose demise was noticed by the English press by the last foreign arrival. She was then said to be ' the best model frigate, and accounted the most completely fitted vessel in the British service.' Modern improvements have made her now a far more formidable ship than she was originally. In speaking of the Macedonian, some speak of her as a sloop-ofwar : she was cantured as a frigate-did service as a frigate-and should be called a frig


