The Superintendent of Outdoor Poor has received no less than ten thousand applications for coal during the last two or three weeks. The same effect two or three weeks. The same official receives daily applications from mechanics who wish to be committed to the Workhouse. Beyond this there is, of course, an immense amount of suffering which is concealed through false pride and shame. Would it not be well for our Republican friends, bank presidents, and so on, who voted for Lincoln, to devise some plan for the alleviation of the misery which the political excitement consequent upon his election has caused in the Northern cities? In the South we find the negroes sleek, fat. comfortable and devoted to their masters. In the North the white laboring classes are walking about the streets with the alternatives of pauperism, starvation or crime. 
