BUCKS CO. POLITICIANS **DEFY THE GOVERNOR**

Republican Leaders Make Clear They Resent Intrusion; Buckman Says "Gang" Will Stay.

The annual meeting of the Bucks County Republican Committee, held in Doylestown today, developed open defiance of Governor Brumbaugh on the part of leaders and supporters of the political machine controlled by Joseph R. Grundy, president of the Pennsylvania Manufacturers' Association. The Governor recently signed the child labor bill which was bitterly opposed by Grundy and his associates.

While Governor Brumbaugh's name was not mentioned by any of the speakers, each of these indicated in a guarded way that it would be to his best interests to keep out of the political fight in Bucks

Among the speakers was Lieutenant Governor Frank McClain. He virtually opened the presidential campaign of 1916 n Pennsylvania by making an attack on the Underwood tariff bill.

He called on the voters of Bucks County and Pennsylvania in general to become volunteer protectionists and also urged them to prepare themselves for next year's campaign. He spoke of "Un-derwood Holidays" and the general panic which followed the adoption of the Un-

Touching on the Governor's attitude on the political situation in Grundy's home county, Senator man, chairman of inty, Senator Clarence J. Buck-Committee in the last Legislature, said: "This is what is known as the Republican Organization in Bucks County. FACT is a real state of things. FALLACY is an apparently genuine but really illogical statement or argument.

NO GREATER FALLACY has been imposed upon public belief, to excite undue prejudice toward the use of liquors, than the stories that "destitution" and "wife desertion" and other miseries are in most instances the result of drink. These FALLACIES have been circulated regardless of substantiated official FACTS to the contrary. Study, for examples, recent data from two widely-separated municipalities:

THE 1914 Annual Report of the Rochester, N. Y., Department of Charities shows that of 3469 cases of destitution in that city, sickness was the cause of 1214 cases; unemployment the cause of 824; old age, 218; desertion, widows left with dependent children, blindness, in-

sanity, etc., 1047 applied for charity. Of the entire total of 3469 cases of destitution in Rochester, during one year, only 166-less than five per cent.-were the result of alcoholism.

IN PORTLAND, Oregon, the same small ratio of liquor misuse is in evidence. During the winter of 1914-15, records were taken of 306 persons applying for aid to the Portland Associated Charities. Under primary causes, 29.7 per cent. of the cases were due to mental and physical incapacity, including illness, accidents, etc.; unemployment caused 25.9 per cent. of the instances of destitution; desertion, 15 per cent.; old age, non-support and other causes, 21.5 per cent. Of the 306 cases needing assistance,

but 24, or only 7.8 per cent. were due to alcoholism. As for the contributory causes of these cases, they followed the same general lines as the primary causes, except that as a contributory factor alcoholism had an even lower percentage-only 4.59 per cent.

T IS a FALLACY to think that excessive drink always auses poverty, when it is a FACT that, reversely, poverty is not unfrequently the most provocative cause of persons trying to drown their troubles in drink!
