

**AR SPECIALTIES
WERE THE LEADERS**

verable Supreme Court De-
cisions Helped Market Late
Day—Bethlehem Leaped.

NEW YORK, June 21.—Under the lead-
ing of the war specialties, the stock
market turned strong before noon today,
and advanced in that group ranging up
4½ points. With the market still
shaken by the vote of the business
shares in the early session, also
prices at the opening were
nearly all advanced under profit-taking.
Nearly all of the business was in
the hands of industrial or war special-
ties, while standard rails and coppers
were selected. Public interest was still
keen, and brokers reported that
traders were doing little on either side of
the market, directly after the opening,
distinctly a waiting one on the part
of the Supreme Court and on
international situations. Stories
from Germany against the Russians
had the effect of inducing some selling,
while the market was opposition by some
German papers to a modification of
marine warfare. It was reported
that the German reply to the United
States note would not be handed to the Ambassador until late next
week.

is regarded as especially
important. In some quarters the opinion
expressed that the District Court,
in the Reading suit is pending, was
the decision in the Lackawanna
before rendering a decision in the
case. An appeal in the Lehigh
case is also pending in the Su-
preme Court. The Lackawanna case was
originally in the District Court
on April 9, 1914, when that
dismissed the Government suit, re-
fusing the appeal to the Supreme
Court.
