McNichol Follower Leads In Race for Judicial Nomination

The Vares, with the assistance of Republican City Chairman David H. Lane, David Martin, Edward W. Patton and Harry D. Beaton sent Judge Morris Dallett to second place on the Republican ticket for Judge of the Orphans Court.

Returns from 46 of the 48 wards in the city gave McCurdy 4,879 and Dallett 3,888, McNichol with Henry J. Trainer, of the 3d Ward, supported Dallett.

McCurdy and Dallett ran neck and neck as the returns filtered in all day. Not until the large independent wards came in did McCurdy overcome Dallett's early lead.

A close contest between City Solicitor Michael J. Ryan and Wessel N. Wessel for one of the nominations for the Court of Common Pleas No. 2 threatens to upset the judicial slate of the Republican Organization.

Ryan ran ahead of Wessel in the 35th Ward, Thomas B. Smith's home ward. He received 1031 votes in that ward to 847 for Wessel. Ryan's largest majority was received in the 13th, where 1502 votes were cast for him, as against 326 for Wessel.

Returns from 35 wards combined, give Ryan 2,461 and Wessel 4,137.

All of the candidates who had the support of the organization for the other Judgeships were nominated without much opposition.

Judging from the returns available today, it appears that Orady, Head and Williams received a majority of the votes cast for the Superior Court candidates, and will have no opposition at the general election in November.

Returns from throughout the State may change this, however, as William D. Wallace, of Lawrence County, polled a fairly heavy vote in the western part of the State.

Judge William H. Shoemaker will be unopposed for re-election to Common Pleas Court No. 4.

Judge Thomas D. Finletter will also be unopposed for re-election to Common Pleas Court No. 4.

Assistant District Attorney Joseph P. Rogers ran far ahead of the field of 17 candidates for the two vacancies in Common Pleas Court No. 2.

With some irregularities, the other behind Wessel, Dougherty and Frederick S. Drake both polled an unexpectedly heavy vote. Four candidates will be nominated for this court.

There is a possibility that Judge Raymond MacNellie will be unopposed for re-election to the Municipal Court. The incomplete returns, however, show that Patrick P. Conway is polling a fairly heavy vote.

Complete returns from 35 wards gave the following for the nominations for Court of Common Pleas No. 2: Wessel, 4,137; Ryan, 2,461; Drake, 1,650; Rogers, 1,218.

Judge Shoemaker received 71,366 votes in the 35 wards for re-election to Common Pleas Court No. 1. Judge Finletter received in the same wards, 51,130 votes for re-election to the same court.

Judge Raymond MacNellie received in these wards a total of 71,738 for re-election to the Municipal Court.

The vote in the 35 wards for the leading candidates for the three Superior Court Judges was as follows:

Head 74,521; O'Leary 73,155; Williams 73,155.

The heavy people cur Judge Orady in the downtown wards. In the 3d Ward of which Henry J. Trainer is the Republican leader, Orady received only 144 votes. Head secured 199 in this ward, Williams 146 and Wessel 76.

Judge Head also lost many Republican votes in Philadelphia. He is a Democrat, and the Organization support of him was half-hearted.

Ryan ran ahead of Wessel in some of the downtown wards. In the 13th Ryan received 933 votes to 771 for Wessel. He ran ahead of Wessel in many divisions of the 13th, but lost to Wessel in the 13th ward gave Wessel 1669 to 1436 for Ryan. Ryan also carried the 35th, 11th, 12th, 14th, 17th, 24th, 33d and 45th Wards.

David H. Lane, who originally opposed the re-election of Judge Dallett, threw all but a few votes in his ward to McNichol. McCurdy received 4236 votes in Lane's ward, the 26th, out of a total of 4267 that were cast. Dallett received 289.

VICTORY COMES FOR MEN WHO WERE SLATED IN MAGISTRATE FIGHT

All Republican Organization Aspirants Nominated—Democratic Factions Name Three Men Each

The nomination of the complete Magistrate slate on each of the party tickets seems assured by complete returns from a majority of the wards. There were no surprises on the Republican and Democratic tickets. On the Washington party ticket the contest was more general than in the others.

On each of the tickets 11 were nominated. On the Republican ballot Alexander Hamilton Brooke polled a vote far above that of any other candidate not of the City Committee slate. In the 1st Ward he led the ticket by nearly 50 votes, polling a total of 1679 against 1623 for George H. Hogg, the high candidate of the Organization slate, and 1399 for John J. Harrigan, the low man.

REPUBLICAN NOMINEES The nominees on the Republican ticket are: John F. Collins, Joseph Coward, William J. Glenn, Frank A. Harrigan, William J. Harris, George K. Hogg, John McLeary, George A. Porsch, Thomas F. Watson, Byron E. Wrigley, Leslie Yates.

Of these, all except Watson, Porsch and Collins, are the present Magistrate, seeking re-election.

WASHINGTON PARTY The mad scramble for office on the Washington party ticket, with 72 names in the Magistrate column, resulted in a low vote for all candidates. The nominees on the 11 slated candidates, however, is virtually assured.

The names of these follow: William F. Beaton, James G. Conner, John S. Deitz, Harry J. Imber, Frank A. Krieger, Alexis J. Limburner, George W. Long, Daniel McAvoy, George W. Porsch, Frank L. Rau, Benjamin H. Renshaw.

The Washington party slate as a whole led in scarcely any of the wards.

DEMOCRATIC RESULTS The Democrats had slated only 30 men, of whom were named by the Old Guard faction and three by the younger organizers. Until the complete returns are available it will be impossible to know who are the other five nominees.

Reorganization candidates nominated are: William H. Belcher, Joseph S. Boyle, John J. Greiss, Frank A. Krieger, Thomas E. Pitzpatrick, The three Old Guard nominees are: Thomas E. Pitzpatrick, William McQuillen, James H. Toughill.

KEYSTONE'S HAD NO SLATE On the Keystone ballot there were 12 names, but no candidates had been slated.

Complete returns had been received from only 41 Republican and 29 Washington and Democratic wards late today, but they indicated that the slated candidates for all offices on all party tickets and on the non-partisan ballot were nominated.

SMITH DEAL REBUKED The Republican voters of the city cast a heavy vote against Smith and repudiated to some extent the manner in which Smith was foisted upon them by the Organization leaders as the "harmony" candidate.

With several of the large independent wards heard from, the combined vote for Porter and Potter on the Republican ticket was 22,219 to 22,159 for Smith, or 60 for Porter.
