

Teutonic allies. Rumania refuses to take an open stand in support of either side by refusing to put her army on a war footing. Allies continue to land troops at Salonika, despite the formal protest of the Greek Government. Premier Radoalaroff Informs Greek Minister at Sofla that Bulengia will not attack Servia unless aggressive action is first taken by the Germans and Anstrians. Official announcement is made in Petro-grad that all diplomatic envoys of the Allies in Sofla are expected to leave at once.

STREET FIGHTING IN MEXICAN TOWN

WASHINGTON Oct. 6 .- Street fighting broke out afresh Euzday at Cananea, Mexico, where there are 50 American women and 350 American men and boys, according to State Department advices this afternoon. Two Mexicans were killed. No Americans were wounded. The acting Governor of Sonora, a Villista general, has assured the American Consul that troops will be rushed to Cananea to provent more rioting. Zapatistas defeated a Carranzista garrison at San Lorenzo, ten miles from Cordoba, in Vera Cruz. many being wounded on both sides. A troop train is reported to have been blown up at Eameralda, near Parjenuevo, and several soldiers wounded.

DEUSIDENT PARDONS DYING COUNTEPEPERER WASHINGTON, Oct. 6 .- Because the prisoner is dying, Frealdent Wilson today committed to expire at once the two-year sentence imposed May 21, 1914, on James M. Baker, of Denver. Daker was convicted of conspiring to counterfeit United States coins.

800,000 ARMENIANS KILLED IN SIX MONTHS

LONDON, Oct. 6 .- Information reaching the British Government indicates that 800,000 Armenians have been slain by the Turks since last May, the Marquis of Crewe told the House of Lords this afternoon.
