

**WILSON NOT WORRIED;
GOES TONIGHT TO SEE
GRANDCHILD BAPTIZED**

President Up Early to Attack
Morning Mail With Smile.
Will Motor and
Golf

WILL TRAVEL ON YACHT

SHADOW LAWN, Long Branch, N. J., Nov. 8.—The uncertainties of the election were faced calmly by President Wilson today. The President arose early and was fresh and smiling as he began work on his morning mail. His activities of the day called for a motor ride and a game of golf if the weather permitted.

At 11 o'clock President Wilson called the executive office for a complete summary of the situation. Secretary Tumulty told him that according to figures at hand it appeared the President had 360 electoral votes, including New Hampshire. The President asked that information be secured as to what any effect there would be on the New Hampshire and Minnesota returns as a result of the National Guard vote on the border. He was particularly anxious to know also from California and New Mexico. He had been informed earlier, however, by phone from western headquarters that California was safe.

The President continues to reserve judgment on the results in spite of the enthusiastic optimism of others of his official family here.

Secretary Tumulty received a telegram from United States Senator Hollis of New Hampshire saying that the State had gone for Wilson by 13 votes. This news caused great jubilation at the summer White House. It was figured here that New Hampshire would make President Wilson 260 electoral votes and that he would be sure of winning if no other of the doubtful States but West Virginia should line up in the Wilson column.

The President went to bed last night about seven o'clock, but members of his staff remained up for several hours watching the returns and attempting to calculate the result. There was apparently less jubilation than yesterday.

The President's household has already begun to pack up for the departure from Shadow Lawn. This evening President and Mrs. Wilson will leave for Williamstown, Mass., to attend the christening of the second child of Mr. and Mrs. Francis B. Sayre, son-in-law and daughter of the President. They will motor to Atlantic Highlands, leaving that point on the Mayflower. At Highlands, N. Y., they will disembark. Then the train will be taken.

No one is making any forecast as to the outcome. At 8 o'clock Secretary Tumulty reiterated his assertion: "It is close, but all right."

Owing to the uncertain result of the election and need for keeping all clerks busy at the executive offices, it will be almost impossible for these offices to be entirely cleared out and moved back to Washington before next week.

JUDGE WALLING HERE

Jurist Expresses Thanks for Election to Supreme Court

Judge Emory A. Walling, who was elected to the Supreme Court bench, arrived in Philadelphia this morning to attend a conference of the judges of that court in City Hall. He was quick to express his thanks for his victory over Charles Palmer, of Delaware County, and when interviewed said:

"I am greatly pleased with the generous support given me at the polls and I wish to express my most sincere thanks to the members of the legal profession, the press, the leaders of the different political parties and the citizens generally.

Judge Walling was anxious to learn details regarding the presidential contest but refused to comment on the situation. He will leave for his home in Erie, Pa., early tonight.

WILL BRING BODY HERE

Philadelphian Killed in Boston Accident to Be Buried in City

Mrs. George Howard Perkins, of 413 South Broad street, the mother of Francis Everson Perkins, who was among the passengers drowned when a Boston street car plunged into a canal Tuesday night, left for Boston in company with the drowned man's brother to bring the body to this city for interment at Laurel Hill Cemetery.

Mr. Perkins was twenty-eight years old and a graduate of the University of Pennsylvania. He went to Harvard to study law, but left college to go into the boat-building business in South Boston. He was a brother of Emily R. Perkins, a playwright, who lives at the South Broad street address.

FEDERAL JOBBOLDERS LOSE

Burke and Sweet Likely to Return to Washington Decks

WASHINGTON, Nov. 8.—Two high Federal office holders defeated Tuesday in their race for elective offices will return to their desks here. They are John Burke, treasurer of the United States, who ran on the Democratic ticket for Senator from North Dakota, and Edwin Sweet, Assistant Secretary of Commerce, who ran for Governor of Michigan on the Democratic ticket.

Burke did not resign as treasurer pending the result of the election and will retain that office. Sweet tendered his resignation but its acceptance was delayed until after the election.
