ENGINEER UNIT GROWS

Active Steps to Organize Regiment of Shopmen for France Taken by Railroad Heads

Pennsylvania led in recruiting for the regular army yesterday, according to a War Department announcement this afternoon. The leaders were Pennsylvania, 208; Illinois, 130; New York, 114.

Recruiting for the Philadelphia engineer reserve regiments that is to be sent to Prance approached the 400-mark today, while final plans were drawn up for the establishment of a city military-agricultural training camp at Byberry for youths be-tween 17 and 26 years old.

They are to work inside shops in France for the dura-tion of the war. n of the war.



It announces that conquest plays no part in the war aims of Russia. This is exactly opposite to the war aims of Russia under

It was offi-cially announced by the former Romanoff Government that the annexation of Con-stantinople and the Dardanelles was the chief object of Russia in the war. 


