30 YEARS IN ONE COMPANY FIRST SERGEANT RETIRES

Not a Bad Report on Record of Soldier, Who Is Congratulated by Officers

WASHINGTON, Aug. 6.—With the retirement today of First Sergeant Styles Trotter, of Company C, Fourteenth Infantry, probably the most remarkable individual record for army service was established.

He has just completed thirty years of continuous service with the same company, the last ten years as first sergeant. Trotter's record is not marred by a single bad report, and with his retirement papers he was the recipient of numerous letters of warm commendation from scores of officers.

A peculiar coincidence in regard to Trotter's service is the fact that he was the first sergeant of the company to which Brigadier General Henry P. McCain, adjutant general, was transferred on promotion as a second lieutenant on graduation from West Point.
