Board of Health Assigns Six Inspectors to Guard Kitchen Sanitation

TO EXAMINE AND REPORT

Physical Status of Employees Also to Be Subject of Investigation to Protect Public

Insanitary conditions in the kitchens of the 4384 hotels, restaurants and lunch-rooms of the city will be removed when six inspectors of the Bureau of Health complete the task assigned them today by Director Krusen...

The inspectors have been ordered to examine and report on conditions in kitchens, iceboxes, dining rooms and store-rooms. They also are empowered to examine into the physical condition of cooks, chefs, waiters, waitresses and busboys.

The law giving the Department of Health jurisdiction over food workers became effective May 28, 1915, but because of the small number of inspectors in the city service only a partial inspection was made last year...

In assigning the inspectors to their new duties, Director Krusen told them that any place found to be insanitary in any respect should be reported at once and the proprietors warned to make necessary changes.

Director Krusen, from experience already gained through the coming into effect of the hotel and restaurant act, gives most of the hotels and restaurants a clean bill of health.

He today declared that there is no necessity for putting in effect here the plan used in New York city, where three different colored cards are issued to the best grade of places, the second grade to those that barely pass the department requirements...

MAYOR AND CITY JUDGE AT ODDS AT SHORE

Friction Results From Bond Reduction of Alleged Philadelphia Gunmen

ATLANTIC CITY, Sept. 12.—A political sensation following the action of City Judge Gaskill in referring to Mayor Bacharach for trial the cases of six alleged Philadelphia gunmen, whose bail he had reduced from \$1999 to \$25, developed new phases today.

Mayor Bacharach tartly refused to perform judicial duties for which he says Judge Gaskill is adequately compensated. The Mayor's newspaper had assailed Gaskill for alleged favoritism of the gunmen. The Judge replied by jumping the bail of three of the defendants found here in \$200 and issuing warrants for the other three.

Judge Gaskill is reported to be a candidate for county prosecutor when the term of Prosecutor Charles Sumner Moore, a Democrat, expires in the spring. The wing of the party with which Mayor Bacharach is affiliated is said to favor ex-Prosecutor Clarence L. Goldenberg for the place. Goldenberg held the alleged gun men in \$1000 bail while Judge Gaskill was out of the city.

\$2,000,000 PROFIT ON SHIPS

Sale of Two Coast Vessels to U. S. Shows Gain

More than \$2,000,000 profit was made on the sale of the Merchants and Miners Transportation Company steamships, Soudan and Soudanette, to the Ocean Steamship Company of Savannah.

Although each of these steamships had been in service for more than six years, they each sold for \$1,010,000 more than they cost to build. This is only another indication of the present high prices that are being paid for tonnage.

CITY REGISTRATION FIGURES KEPT SECRET

Will Not Be Made Known Until After Close on Saturday Next

ORGANIZATION PLANS COUP

Small Total of First Two Days Concealed With View to Deceiving Independents

No registration figures for the first two days on which electors could qualify for the fall election will be available until after the first two days, so that the independent voters would not be aroused, was seen in the announcement.

The Board of Registration Commissioners is controlled by the Vares, who are the registered voters in the city wards and who have "fathered" the "fifty-fifty" ticket for row offices placed in the field by the organization. By keeping secret the small registration of the first two days, it was pointed out today, they could register the full strength of the organization to force the nomination of their slate at the primary election, September 19, and hand-pick the independent voters in any plan the latter might evolve for fighting the organization ticket at the general election by not arousing the independent voters so that they will register next Saturday.

The Vares-sponsored plan failed to work out yesterday, however, according to unofficial reports of the second day's registration. Although Senator Penrose, the Vares, Attorney General Francis Shunk Brown, and other organization leaders came to Philadelphia in order to register, the organization failed to bring out their full strength, especially in the wards where there is dependent political strength.

Ward leaders all over the city today "complained" that most of the electors who registered yesterday were those who would vote against the organization ticket. This is the first year in which the registration figures for the first two days will be available before the third and fourth days. Official reports indicate that September 6 the first day, only about 5000 were registered, and that yesterday, the second day, only about 50,000. This is one-half of the normal registration. The announcement that the figures would not be available was made by the Board of Registration Commissioners.

The figures have not been completed yet," he said, "and they will not be announced until about the first of next week. Saturday is the last day on which electors can qualify for the primary and general election this fall.
