CALLS STATE FIREMEN TO CAPTURE FIREBUGS

Judge Bonniwell Urges 150,000 Volunteers to Guard Against Treachery

The alarming increase of incendiaries, causing a loss of more than \$60,000,000 worth of property, food and munitions in the United States and abroad, is due in large part to the activity of German agents in this country, has caused Judge Eugene J. Bonniwell, president of the Firemen's Association of Pennsylvania, to issue a special appeal to the 150,000 firemen of Pennsylvania to exert every energy in the prevention of incendiary fires and to constitute themselves "the keystone of the State defense against treachery and destruction."

The State has been divided into seven districts by Judge Bonniwell, and chairmen appointed in every district as the nucleus of an effective organization to combat the firebug. The goal is to have a list of names of all firemen in the State to constitute the State Firemen's Committee of Public Safety.

A full list of committee appointments and county vice presidents was named by Judge Bonniwell. On the law and legislation committee Senator William H. Starna, candidate for Governor, was named. City Solicitor John P. Connolly, of Philadelphia, was again named director of the organization.

PLEA FOR PORT OF PHILADELPHIA LAID BEFORE DIRECTOR M'ADOO

Transportation Committee of Allied Trade Bodies Shows Means of Unraveling Tangle

Future of Philadelphia's Superior Port Facilities Now Up to McAdoo

USING the facilities of the port of Philadelphia is now up to Director General of Railroads McAdoo. Through his assistant, A. H. Smith, of New York, the facts have been placed before him by Director George S. Webster, of the Department of Wharves, Docks and Ferries.

Congressman John R. K. Scott has told Mr. McAdoo that the Garfield suspension order was without results in Philadelphia's tributary territory because shipments from that territory continued and are continuing through the port of New York.

Investigation by the EVENING PUBLIC LEDGER has disclosed the following advantages of the port of Philadelphia over the port of New York:

NEW YORK DELAY caused by lighterage, which is an essential of that port. PHILADELPHIA Railroad facilities eliminate lighterage.

NEW YORK Extra ninety-mile haul eliminated. PHILADELPHIA Extra ninety-mile haul eliminated.

NEW YORK Piers piled to overflowing with freight and excess piled high in streets adjacent to piers. PHILADELPHIA Piers filled to only 15 per cent of capacity.

NEW YORK Ships delayed at piers by lack of bunker coal. PHILADELPHIA Plenty of bunker coal available.

NEW YORK Ships lying idle in harbor waiting berths to be vacated by coal-less boats. PHILADELPHIA Only one-third of berths in port occupied.

All of these facts were laid before Mr. McAdoo by Director Webster, through Mr. Smith's office. Mr. McAdoo has all the necessary data available. The question has been put up to Mr. McAdoo. What will McAdoo do?

SNOW AGAIN CLOGS SHIPPING OF COAL

Reading Company Clears 1000 Cars, 400 Below Its Average of Work

READING, Pa., Jan. 28.—Because of the snowstorm the hard-coal shipments from the Reading Company's collieries were only 1000 cars loads of forty tons each. The company in normal times sends 1400 cars to market. Every available engine was put on the road, but the size of the trains had to be cut down on account of the cold weather, of yesterday's shipments, it is not believed that Philadelphia will get more than the daily average of the last week, but this will not be known until today.

The congestion of freight and coal cars on the Shamokin division has been somewhat relieved. SHAMOKIN, Pa., Jan. 28.—With passenger crews and engines in coal and freight service, local yards and colliery sidings virtually were cleared of anthracite, but there were unusually heavy movements of bituminous coal. In consequence, the blockade continues.
