Commerce Body's Industrial Relations Committee Aims to End Labor Troubles

EFFICIENCY ALSO SOUGHT

Protection of the public in industrial arfare and bringing about of efficiency production are among the aims of the industrial relations committee, which has been established by the Chamber of Commerce of Philadelphia. hamber of Commerce of Philadelphia. The platform of the committee fol-

The general purpose of the industrial relations committee of the Chamber of Commerce is to unite the constructive elements of the community for the pro-tection and promotion of the public interest and welfare in the field of employment relations in the city's in-dustries:

By the endeavor to bring (n) about a general recognition and ob-

(b) By the use through co-operative action of the moral and material resources of the committee and its representative interests in defense of such principles when such action is necessary.

Principles to be Defended

The principles which the industrial relations committee of the Chamber of Commerce of Philadelphia is created to promulgate and defend in the public interest are as follows: First, Employment relations should

recognize, and conform to those principles of individual liberty, freem of contract and equality of opportunity which form the basis of our national institutions.

The right of open shop Second. operations, that is the right of the individual to enter and pursue any lawful trade or calling and to contract with others as employer or employe upon terms mutually accept-able is an essential part of the personal liberty of the individual. Third, While other employers or

workers in the furtherance of legitimate self-interest have the right to combine for collective action or dealing, such combination has no right to compel others by intimidation or correlon to accent its control. Fourth. Collective agreements be-

tween employers and chaptoves, vol-untarily entered into and not against the public interest, should be observed and performed by the parties with the same faith and credit as applies

to any valid contract. Fifth. The power of industrial combinations whether of employers or workers is rightly accompanied by corresponding responsibility. Where there is a lack of full legal responsi-bility on the part of such combina-tions for breach of agreement or violation of the rights of others, it is essential that they be held by the community to a higher degree of moral nsibility for their conduct.

Sixth. Combinations to establish sixin. Combinations to establish a monopoly of the production of labor and to bar the competition or ake away the opportunity of livelihood of those outside the combination, are against good morals and the public interest.

Innocent Parties Hurt

Seventh. The right of an industrial group to use its economic power for the henefit of its members is re-stricted by its obligations to respect the right of others. The use of the sympathetic strike or lockout or of ne boycott involves an attack upon nocent third parties and the public.




