



MUST NOT ANNOY WIFE

Man Is Held on Charge of Writing Threatening Letters

Threatening letters she had received from her husband recently led the wife of James Hagan, twenty-eight years old, of Chicago, Ill., to have him placed under arrest.

He was held under \$100 bail this morning by Magistrate O'Farrell at the Nineteenth and Oxford streets station, on an order that he keep the peace and stop disturbing his wife. The couple have been separated since September.

Mrs. Hagan explained to the magistrate that she had received the following letter from her husband a few days ago:

"The first time I see you on the street or in church I shall put a bullet through my head. If I ever see you with another man we will both go to the morgue together. I will not have any feeling. My Irish is up and I will have you dead or alive. My blood will be on your hands."

Yesterday afternoon Hagan went to

the apartment of his wife, Velah Hagan, at 1222 Crooket street, and though he was not disorderly and did not create a disturbance, Mrs. Hagan called for the police and had him placed under arrest.
