DEVELIN TO FIGHT CONTRACTORS' BILL

Councilman Will Oppose Act to Make Up Profits Lost During War

VARE IS NOT INTERESTED

Protest will be made by Councilman Develin against a bill which he says would enable contractors to recover profits lost on work during the "inflation period" caused by the war.

Mr. Develin, who will be in Harrisburg Monday, "The contractors, it is said, contend that they lost heavily because after they bid on work there were big and unusual increases in the cost of labor and materials."

"I am opposed to extending any aid to contractors beyond actual losses sustained. In view of the circumstances I think it is fair enough to make up for losses, but I do not think of extending conditions that contractors should put in claims for profits."

Although it was reported that Senator Vare was behind this bill, he said today it would not interest him in any way financially.

"I understand that this bill will be introduced at the suggestion of the State Highway Contractors' Association," he said. "I think it is only fair that those men who contracted for work at pre-war prices and were then compelled to go through with it after the prices of labor and materials were greatly increased, should be compensated for their losses."

Miss Harding, who, with her niece, Mrs. Frank E. Biggs, of Oakland, Calif., is visiting at the home of Mrs. James McCallan Williams, 6282 Woodbine avenue, Overbrook, is a teacher of English literature in the Marion High School, and she has too great an interest in that profession to abandon it, and allow herself to become known merely as a relative of Warren G. Harding, President of the United States.

Miss Harding is tall and trimly built, charmingly at ease everywhere, and with blue eyes which bespeak friendliness and fellowship. She is very much impressed with our parks here, and is looking forward to another visit when she can see the famous landmarks of history. She is leaving this afternoon for Buffalo, where she will make a short visit before returning to Marion. Mrs. Biggs will go from here to Washington.

"Of course," said Miss Harding yesterday, "I expect to go back and forth between Washington and Marion, but I shall continue to make my home with my father. And, besides, I want to continue my work. I have always been interested in teaching, and I think those who like it should continue to teach."

PANAMA OBJECTS TO WHITE AWARD

Will Not Accept Plan as Basis of Peace With Costa Rica

WILL KEEP POLICE IN COTO

By the Associated Press. Washington, March 10.—Panama refuses to accept the White award as a basis of peace with Costa Rica, it informs the American Government in a note made public today by the State Department.

The note is in reply to that sent to Panama and Costa Rica last Saturday by the State Department demanding immediate cessation of hostilities and was made public without comment. Panama agrees to the retirement of its troops sent to Coto after the appearance there of Costa Rican forces, but it announces its intention to keep the civil and police authorities in Coto where they were prior to the break between the two governments, February 21.

Costa Rica already has withdrawn her troops from the disputed territory, and has agreed to a settlement on the basis of the White award. Panama, by the withdrawal of its troops, has restored the status quo, but it is understood that the United States will insist upon the gradual withdrawal from the disputed territory of the civil government in order to clear the way completely for final adjustment.

BONUS FOR 120,000 IN N. J.

Soldiers and Their Dependents to Share in State's Bounty

Trenton, March 10.—The New Jersey soldiers' bonus commission, consisting of Adjutant General Frederick Gillison, State Comptroller Newton A. Hughes, State Treasurer William F. Read and Major Leonard Coyle, state commander of the American Legion, issued a bulletin today which explained in detail the operation of the soldiers' bonus law, adopted by the Legislature last year.

The commission estimated that about 120,000 persons were entitled to the bonus. The dependents of deceased soldiers are also entitled to \$10 a month for each month or fraction of a month in service, the total amount of any person's bonus, however, not to exceed \$100.

The bonus appropriation will not be available until July 1 of this year, and applications may be obtained from the commission at the state house, from units of veterans' organizations, or from Red Cross chapters. All applications must be made within one year after the bonus act becomes operative, or in case the person is still in service, within one year after his discharge.

HIGHER COMPENSATION SUPPORTED

Harrisburg, March 10.—The House committee on insurance reported affirmatively the Goehring bill providing for an increase from 60, as now, to 60 percent of wages in compensation to be paid for loss of arms, legs, eyes or other features of the body in industrial accidents. This is an amendment to the general compensation law.
