


Asbury Park, N. J., March 10. Through a resolution passed at this morning's session of the New Jersey Methodist Enisconal conference, the United States is congratulated upon the induction into office of "such a Christian gentleman as Warren G. Harding." Reference was made in the Harding." Reference was made in the resolution, which was prepared by the Rev. Dr. John Handley, of Long Branch, an army chaplain during the war, to the fact that President Harding had selected the George Washington Bible in taking the oath of office and chosen a verse from the book of Michael as the watchword of the administra-tion

"By his reference to providence. the resolution states, "he has committed himself to the positive side of Chris-tianity, and we agree to uphold his hands in the arduous tasks that are set before him, nationally, territorially and internationally; and we will do all in our power, by our prayers, our loyaty. our Americanism and confidence, to further his mature plans for the ma terial and moral progress of our nation and of the world."

Trenton District Prospering The Rev. Melville E. Snyder, super-intendent of the Trenton district, gave his annual report yesterday in which he stated that during the last six years the increase in full members had been more than 2500, and 6810 probationers the increase in full members had been more than 2500, and 6860 probationers have been reported. 

# The **Telephone Ringing** Signal

THE installation of the telephone ringing I signal, announcement of which was made recently, is now completed in all Philadelphia central offices. As explained at that time, it is a low burr-r-ing sound followed by a distinct pause and then a renewal of the burr-r-ing sound. It continues until the telephone you called answers, or you hang up your receiver, or the operator tells you they do not answer.

The ringing signal should not be confused with the familiar "busy" signal which is a much shorter and louder "buzz-buzz-buzz." The latter is a very distinct indication that "the line is busy."

The ringing signal gives you definite audible notice that the work of connecting your telephone with the telephone you are calling has been performed by the operator and that the called telephone is ringing.
