

WOMEN TO DISCUSS BOSSES IN POLITICS

Election Methods and Machine on Program Today at National League Convention

SUBMIT REPORT ON POLICY

Cleveland, O., April 8.—Every angle of the present-day activity in American politics of political bosses and political machines will come up for action before the second annual convention of the National League of Women Voters, which opens here Monday.

The board had before it today a report on policy submitted recently by Miss Katherine Lindington, of Hartford, Conn. In this report the national league is offered a choice between two policies.

One is to develop a well-informed woman electorate in America, to reach all women, teach them how to vote and whom to vote for.

The other is to put through as rapidly as possible a program of legislation considered beneficial to the women of the nation at large.

If amendments to the national league have prepared by the board yesterday are adopted by the convention, national officers will be elected by the delegates instead of being the choices of elected regional directors.

State women's voters league chairmen began arriving today for a conference Sunday between the national board and the state chairmen. Meetings of the regional directors and chairmen of standing committees also were held today.

\$150,000 BALTIMORE FIRE

Blaze Started on Scene of City's Greatest Destruction

Baltimore, April 8.—(By A. P.)—Fire which broke out shortly before 2 o'clock this morning swept the lumber yard and plant of Joseph Thomas & Son, in South Baltimore, and threatens many industrial properties in that section. All fire apparatus in the city has been called out.

At 2:30 o'clock, Fire Chief Emerich said the fire would be confined to the lumber plant. William Layton, treasurer of the lumber company, said the loss was \$150,000, fully covered by insurance.

The fire today was in the plant of a company that had been the scene of another disastrous fire. Back in the early 70s a blaze that swept a large area in Baltimore started in the plant of the Thomas company.

BRINDELL BREAKS JAIL RULE

Eats Ham and Eggs and May Be Demoted
Ossining, N. Y., April 8.—Hash was on the dinner menu last night at Sing Sing Prison, but Robert P. Brindell, high-salaried labor leader, who began a five-year sentence Monday for extortion, ate ham and eggs. Charges for violation of the prison rules are being filed. The warden, another convict, from whom Brindell said he obtained the delicacies, was deprived of his usual privileges and locked in a cell.
The only inmates of Sing Sing who are permitted to eat eggs are patients in the hospital. Brindell will be tried before the warden's court. If found guilty he will be placed in grade "B" and lose many of the privileges that ordinarily would be accorded him after two weeks at the prison.
Brindell yesterday was put to work washing a hand-poller over the lawn at the prison. His working hours are from 8 o'clock to 4, with an hour for lunch.

MAN SLAIN IN ITALIAN RIOT

Socialist Headquarters Is Burned. General Strike Called at Padua
London, April 8.—(Office of the Chamber of Labor in Padua, Italy, were burned last night by members of the extreme Nationalist group, says a Central News dispatch from Rome.)

The Socialists at once proclaimed a general strike, and formed a procession with the intention of burning one of the Nationalist clubs in the city. While marching through the streets, the Socialists encountered a procession of Nationalists, and in the fighting that ensued one man was killed and many injured. The Socialists were routed and dispersed.

The dispatch quotes the newspaper Tempo, of Rome, as stating that thirty-nine anarchists have been arrested at Ferrara on the charge that they were implicated in a plot to bomb Nationalist clubs, a theatre and several cafes.

HUGE JERSEY ROAD PROGRAM BLOCKED

Senators Refuse to Agree to \$50,000,000 Expenditure as Session Ends

18TH AMENDMENT LOSES

Trenton, April 8.—With the New Jersey state Legislature due to adjourn this afternoon, prospects for the \$50,000,000 road program seem to have gone glimmering for the present.
After having refused early in the week to approve the plan, the House yesterday jammed through a committee substitute for a number of bills adding 300 miles to the state highway system, over a period of fifteen years, at the cost of fifty millions, but the measure encountered obstacles in the Senate and no agreement could be reached in conference between Republican leaders of both houses.

Automobile and trade interests of both New Jersey and eastern Pennsylvania backed the plan, but Republican senators feared that the piling up of such a huge debt would be unpopular with the mass of people of the state.

The Senate also has refused to approve the proposed bridge and tunnel and the \$16,000,000 necessary for the soldiers' bonus.

Assemblyman Pierson, of Union, denounced the additional expense on the state. He predicted that the logging would bring a rebuke from the electorate. Assemblyman Moore, of Hunterdon, and Boswell, of Cape May, ad-

vocated the further extension of the highway program.
Mrs. Van Ness, of Essex, and Assemblyman Cramer, of Ocean, supported the arguments of Assemblyman Pierson.

Two More Vice Chancellors

Chancellor Walker is given authority to name two additional vice chancellors for the Court of Chancery under the provisions of a bill signed last night by Governor Edwards.

South Jersey lawyers, through their representatives in the Legislature, urged passage of the bill. Barristers from the northern counties approved the plan to appoint an additional jurist for that section. The act is permissive and gives the chancellor discretion to appoint the additional court members when, in his judgment, an increase in the court's membership is advisable.

With one branch of the court in Camden, South Jersey lawyers are understood to favor establishment of a branch of the Chancery Court in Atlantic City. Paterson's practitioners are insisting upon a resident vice chancellor for that city.

George A. Bourgeois, of Atlantic City, and County Judge John W. Kates, of Camden, were mentioned today in connection with the additional vice chancellorship appointment for South Jersey. Both are Republicans. Judge Kates' term expires next year.

Bridge Measure Approved
John Hillton, of Jersey City; William B. Gourley, of Paterson; United States District Attorney Elmer Geran, of Matawan, and Errors Court Judge Henry E. Ackerson, Jr., of Kew-Forest, are mentioned for the North Jersey place.

Governor Edwards has approved the Senate Barber bill appropriating \$200,000 to the free bridge commission to purchase structures spanning the Delaware river.

Only ten of the twenty-one senators could be mustered for the House Roberts resolution for New Jersey to ratify the eighteenth amendment to the United States constitution. Final adjournment of the 1921 Legislature today finds this state still unwilling to subscribe to the

amendment, although it has passed an enforcement act far more drastic than the Volstead act.

The Anti-Saloon League early in the session had the ratification resolution brought up in the Senate. It failed by one vote then. The line-up yesterday was unchanged. The league is dumfounded at the Senate for accepting every bill offered by it, but withholding ratification of the amendment.

The vote on the resolutions follows: In favor—Allen, Bright, Hagaman, Mackay, Parry, Reeves, Runyon, Sturges, Wallworth, R. H. White—10. Opposed—Brown, Case, Henth, Simpson, Smith, Stevens, C. D. White, Whitney—8.

Highway Bill Is Passed

Armistice Day will be a legal holiday if Governor Edwards approves the House Dater bill, which has passed both branches of the Legislature.

Colonel Anthony Kuser's offer of his palatial residence at High Point, Sussex county, for use as a New Jersey home for wounded veterans of the world war, was accepted by the Senate yesterday in adoption of Senator Kay's bill for the state to take over the property. The proposed institution is valued at \$74,000.

Senator Kays said Mr. Kuser had

turned down an offer of the United States Government to purchase the property for disabled soldiers, preferring to give New Jersey a first option.

NEW ATTACK ON SUFFRAGE

Case Argued in Maryland to Upset Nineteenth Amendment
Annapolis, April 8.—Attacking the Nineteenth Amendment from a new angle, opponents of women's suffrage were heard in the Maryland Court of Appeals yesterday. The case arose on the refusal of registers in one of the precincts of Baltimore to decline to accept certain women who applied to have their names placed upon the registration books.

It is alleged the Nineteenth Amendment was not actually an amendment, but a "revolutionary change" in the form of Government of the Nation, and an attack upon State sovereignty. Decision was deferred.
